On Wednesday, February 2, 2022 Tishomingo County High School had two Football Players sign to play at the next level.

Blake Counce, who was featured as Quarterback for the Braves the past two seasons, has signed an NLI to play with the Millsaps Majors, an NCAA School located in Jackson, Mississippi. According to Head Football Coach Richard Russo, Counce is expected to play Slot Wide Receiver and Kick

Returner for the Majors.

Counce had this to say of his signing, "I have grown up in a family that loves football and loves to compete. I am looking forward to being able to go out and compete with the best of the best at the collegiate level. I will definitely miss the high school atmosphere, my teammates, and my coaches. ## **Burnsville Man Arrested** for Failure to Register

The Tishomingo County Sheriff's Office has been conducting an investigation into a registered sex offender falsifying his registration. On January 31, 2022, The Tishomingo County Investigators received information that, Mr. David Wayne Roberts, a 51-year-old, white male of Burnsville, Mississippi, was residing at a home located within 3000 feet of a school as a registered sex offender. A warrant was issued for the arrest of Mr. Roberts. On January 31, 2022, Mr. David Wayne Roberts was arrested and charged with failure to register as a sex offender. On February 2, 2022, David

sex offender at \$15,000 and Sex Offender residing within 3000 feet of school or child care facility at \$15,000 totaling \$30,000 bond.

This case remains under investigation and more charges may be pending. This case will be presented to the next available Grand Jury.

### **Increased Law Enforcement** Presence in the Tishomingo **County School District**

A threat made towards an unspecified school in North Mississippi led to an increased police presence at all schools in the area on Monday, February 7th.

The Lee County Sheriff's Department received a tip from the FBI on February 6th that a threat was made on a social media app towards a school. The company which owns the app flagged this threat and immediately contacted the FBI. Lee County then shared the information with all schools and law enforcement in the area.

According to the Lee County Sheriff's Department, an arrest was made on Monday morning around 9:30 a.m. without incident, of an underage individual who allegedly made the threat. Lee County Sheriff Jim Johnson

stated "there was no indication that the suspect had any intent to go through with the threat but any threat made towards a school, students, and or staff is taken very seriously and will be prosecuted." Any charges brought against the individual will be handled through Lee County Youth Court.


This threat came days after the Tishomingo County High School informed parents of an "Air Drop" message informing students not to come to school on Friday, February 4th. The message was received on Wednesday, February 2nd. No actual threat was made in the message but law enforcement presence was increased on Friday. The two incidents were unrelated.





"Howdy," was a common everyday word where I grew up. Raised on old Stidham, now known as Milo road in rural Appalachia, I spent a lot of time at my Grandpa and Grandma Hinkle's store. People came and went buying gasoline, sandwich meat, snacks or groceries for the week. There were cane bottom chairs in the store. Often people would sit and chat for a while.

Regardless of how many times during the week I walked down the road to that store, the opening salutation was typically, "howdy."

People were in and out of the Hinkle store doing business. A family member was often coming or going because my grandparents had raised ten children and there were many grandchildren who frequented the Hinkle business. Often, family members were buying a soda pop or just stopping in to say "howdy."

We grew up on Milo speaking to most everyone who came and went. When a car drove by, we usually waved even though we didn't always know them. At family or church gatherings we typically talked to everyone for a minute or two and shook hands or hugged a few people.

The only time I can remember our family being speechless was when fifteen or twenty of us were sitting on the porch and a man from New York City pulled up in an older car. My grandpa had received an advertisement in the mail about a great used car he could buy for \$500. He ordered the car to surprise my grandma and we were all really surprised when this man pulled in front of the store in an old beat up looking car. He had driven the car from New York City, which was a long drive on those roads back then. After being drop jaw stunned silent for a few minutes, everyone loos-

ened up and eventually

started talking to the man who else is in the grocery who was just doing a job but now had to get back to New York. By this time, some of us were chuckling just a little. A couple of the family members took the guy over to Kermit, West Virginia to catch a Greyhound bus to begin his long journey back home.

A part of American culture has been hand shaking and embracing those we know. A part of most American religious gatherings has been shaking hands. One church I attended insisted on everybody hugging each other.

Covid-19 has impacted our world with death, sickness and business failures. The distancing for many of us continues to be tough. We wear our masks and seldom know

store. We're fearful of going to the funeral home to honor and respect the deceased. Shaking hands or embracing anyone anywhere is typically totally unwelcome. Many holiday parties of large gatherings were fewer over the past holidays. People don't want to be sick and so the distancing continues.

We do have the telephone, social media and email which helps us at least stay connected.

However, please keep in mind, when you do recognize someone at the grocery or any public place you may not feel comfortable embracing or shaking hands, but you can still convey a greeting and kindness by at least saying "howdy."

## I Remember

A few days ago there was a question concerning the "Clipper" on FaceBook about this passenger bus. I announced with a few remembrances of the Clipper. Yes, I rode it to Corinth to shop a few times. After I've had time to get my thoughts together, I'm going to share a little more about our clipper passenger

As I recall, it started its route at Booneville on highway 30, the crookedest road probably in Tishomingo County. When it reached highway 25 at Tishomingo, it turned north.

It ran north on highway 25, just newly straightened. It stopped and picked up passengers standing along the road waiting. Since the Dee Dawson home (Kim and Teresa) was at the intersection of highway 25 and what is now CR 55. (This road was old highway 25). There were usually several waiting for the clipper. It went on north to Midway and turned west on 364 to Holcut, then Reinzi to Biggersville and 45 on into Corinth.

I thought the clipper parked and remained there until we loaded to return by the same route. As I remember, it didn't run every day but had a regular schedule.

Grandpa Dee Dawson had an elderly cousin who lived in Boonville, Lana Dawson Harrison. He would catch the bus and come spend the day with Grandpa Dee. They would sit on the front porch until Mrs. Dawson (Carrie Ligon) called them to "come and dine" then back to the front porch for more talk until time to catch the Clipper back to Boonvile.

Someone asked me

how much it cost to ride the bus to Corinth? I don't know, but not much. I was in college each spring and fall while the schools were closed for hoeing cotton in the spring and picking in the fall. I taught when school was in session.

Mrs. Dawson, Ches ter's mom, caught the bus to Corinth quite often. It is ironic when I think about her spending the day in Corinth alone. When she got off the bus she would have a little brown paper bag with lace, buttons and thread to trim the material she had bought at Mrs. Emma Brown at Iuka to make a dress.

When she'd get the pattern and the fixings above, one of the boys or usually me, would carry her to the seamstress (seems like Mrs. Champion.) Usually it took three trips to the valley. There had to be a fitting before it was ready to pick up. She wasn't extravagant in dress, just meticulous.

Back to highway 30. J. D. Southward, Jr. ran for office and was elected. He had graduated high school in 1945.

I don't recall if he was a Senator or a Representative but he was a good politician. He wanted to get highway 30 to Boonville straightened. He did. I'm sure he said "You scratch my back? I'll scratch yours." Prompted this twenty miles plus, that was so crooked got approved and straightened. It bears his name as you enter this county at Benton. After this project was completed, he retired. It may have been because his dad died and being an only child he had the store in Tishomingo and a farm to manage. Tishomingo Baptist Church bought the Southward home and used it for S. school

room and a fellowship hall for a few years.

As we grew more space was needed and the house was torn down, and the Tennison Fellowship building was built. When they were cleaning the area for the building there was a beautiful rose bush. It was dug up and moved to the new pastoriam occupied at the time by Brother Bill and Katherine Langley, on highway 25. It continued to thrive. I tried to root a rose bud two or three times. No Luck.

One day our pastor, Dr Pinkerton, drove up with a bucket. In the bucket was a rose bush growing. It was a cutting from the Southward rose bush and a gift for me from the plant I had tried to root. I am still enjoying this precious gift from the original. I think it is the "seven sister" old people used to call this bush. It has a seven blossom-cluster on one stem. 
