County Board discusses accommodating Northrop Grumman expansion at Tri-State

The county board of supervisors met Tuesday morning for regular business and to meet with local industry Northrop Grumman about leasing additional space to accommodate an expansion that could mean 400 more local jobs.

Though the portion of the meeting with national space and defense contractor Northrop Grumman

was in executive session, since lease negotiations were the subject, board members discussed several times ways to accommodate the company's request to lease a large portion of Building 1000, prior to the closing the public session.

Hubbard Salem Voting Precinct County election commissioners Pete Walker, Sherry Gwatney and Beverly Ragan met with the board to request that the recently established Hubbard Salem

voting precinct location be allowed to remain in a small location of Building 1000, even if Northrop Grumman takes over the building.

First District Supervisor Brandon Grissom stated, via telecom, that he hopes the industry can still allow the election commission to operate the polling place that is used just one or two times a year, at most. Accommodations have already been made to make

the precinct ADA (Americans with Disabilities Act of 1990) compliant, including a concrete ramp, explained Grissom. Moving in a small portable building would be another solution, but the board hoped to convince Northrop Grumman to accommodate the need to use the small space for elections for the about 150 voters who use it.

The issue is that Northrop Grumman






