## Tishomingo County Master Gardeners Dedicate Greenhouse

IUKA – Tishomingo County Master Gardeners drew dozens of supporters Monday to help celebrate the dedication and ribbon-cutting for the group's greenhouse.

Betty Owen and Barbara Patterson did the honors by cutting the ribbon in memory of their late husbands, Danny Owen and Tom Patterson.

"We are so honored to have them here for this special event," said County Agent Zach Yow.

Owen served as county agent for the Mississippi State University Extension Service for more than 25 years and became a dedicated master gardener after his retirement. He died in 2018.

Patterson was in the first class to complete the Master Gardeners' course in Tishomingo County and had a long-time desire for the Master Gardeners to build their own greenhouse. He died in 2020.

Patterson was a member of the committee that began in late 2019 evaluating the feasibility of a greenhouse, and Tishomingo County Master Gardeners voted to dedicate the new facility to the two men. Area artist Tony Bullard was asked to design a sign for the greenhouse grounds to honor them, as well as others who gave support to establish the greenhouse.

"Thank you for celebrating with us, and thank you to all the officials and vendors who supported us," said David Day, president of Tishomingo County Master Gardeners.

Day noted many entities that gave financial and material support to the project: Needle Chasers Quilt Guild; Tishomingo County Board of Supervisors; city of Iuka; K & T Concrete; Milligan Ready Mix; German Installations, Tishomingo; Home Depot, Florence, Alabama; Fairless Hardware, Tishomingo; Mr. Stripes, Tishomingo.

"Of course, our master gardeners' group has

been supportive all the way," Day said. "When we have our plant sale on April 23, customers can feel good knowing the plants they bought were started and grown by their neighbors."

Also attending the celebratory event was Dr. Jeff Wilson of Mississippi State University Extension, who is state coordinator of master gardener programs.

"I worked with Danny for about 10 years," Wilson said, and shared a brief anecdote about their friendship. He also emphasized the important role that master gardener groups serve throughout the state.

"There are 60 master gardener groups in our 82 counties who give about 80,000 hours of volunteer service each year," Wilson said. "We couldn't do our jobs without the help of master gardeners, and I'm very excited about this greenhouse."

In 2021, Tishomingo County Master Gardeners sold about 700 plants at its annual sale, with more than 500 tomato plants germinated in the greenhouse just as construction was completed.

This year more than 700 tomato plants alone, as well as other vegetables, fruits, and flowers are being germinated, rooted, and propagated for the April 23 sale, which will be 8 a.m.-1 p.m. at the Tishomingo County Fairgrounds.

Proceeds from the plant sale support various projects such as plantings at Jay Bird Park, container plants at each of the county libraries, a new project at the Old Tishomingo County Courthouse Museum, and others.

Tishomingo County Master Gardeners welcome new participants. Spring classes are already underway, but a new fall class will begin later in the year. For more information call the county extension office at (662) 423-7016.

#### Iuka Opts Out of Medical Marijuana

#### - For Now

Like municipalities all over the state, the city of Iuka board of aldermen voted Tuesday night to opt out of allowing the sale and manufacturing of medical marijuana in the city.

The law passed by the legislature and signed by the governor allows for counties and municipalities to opt out of any one segment of the medical marijuana business while allowing others, including cultivation, processing, sale or distribution.

The concensus of the aldermen was to wait and see how the rules and regulations would look in practice before considering to opt in their one allowed time.

In other news, the board denied a request for an open container event to fundraise for Iuka Boys and Girls Club, saying it sent the wrong signal for boys and girls to be involved. No one involved spoke to the board about the event.

#### **Rezoning Requests**

The board denied a petition to re-zone from "residential" to "commercial" the historic Painted Lady home at Mineral Springs Park, stating they had heard from neighbors who were against the idea. The house has been for sale for some time, and the potential buyer is reportedly interested in operating it as a bed and breakfast, and later as an event venue.

Neither proponents nor opponents of the rezoning appeared at the 6 p.m. rezoning hearing, as required in a public notice. The board allowed supporters to speak during the regular meeting, even though they arrived for the regular board meeting and not the hearing.

Supporters gave strong arguments for the economic boon an event venue like the one planned could mean to the city, describing how groups would love to come stay in the lavishly renovated antebellum home, visit nearby downtown shops and get the ultimate small-town experience. They urged the board to vote in favor of growth and to take advantage of a one-of-akind opportunity the availability of the historic home presents.

They did not outline any plans to address potential concerns like parking or noise con-

The man who shot nearly everyone's pictures in the county at one point or another passed away Saturday.

Charles Swimmer, of Photography by Charles, was a Tishomingo County institution; a character easily recognizable behind the camera everywhere from elementary schools to beauty pageants. And he was a huge contributor to the community as an active member of Iuka Rotary, the Iuka Heritage Day Committee, and many more organizations.

At the Iuka Board Meeting Tuesday night, Iuka Mayor Joel Robertson noted the loss

the community feels in the death of such a devoted volunteer.

"He played Santa for years in the Christmas parade, and volunteered for many, many city events," said Robertson. "He will be missed by us all."

He began his career in photography in the U. S. Air Force where he served three tours in Vietnam. He opened Photography by Charles in Iuka in 1975 and remained in business for 38 years.

He even hung around the Tishom-

ingo County News offices years ago, providing images and using the on-site dark-room when he needed to, since he didn't have one at his Front Street studio.



trol. The actual potential buyer was not present, reportedly.

Aldermen Emily Wadkins and Nancy Stripling said they had a letter and had spoken to residents opposed to the idea prior to the meeting, but apparently had heard from no one supporting the idea. They did not identify any of the opposing opinions at the meeting.

The homeowner, eager to sell due to family health concerns was very disappointed with the decision.

The board voted to grant rezoning from "residential" to "commercial" property owned by the Iuka United Pentecostal Church, who plan to open a school and daycare behind their church.



#### Snowdown School Was Where Present Day Iuka Country Club Sits

This wonderful photo of the old Snowdown School located in the Snowdown/Oldham community northeast of Iuka is being shared with our readers by Betty Fell Marlar. Betty only attended school at Snowdown for two years, 7th and 8th grades, before she graduated and went to Iuka. This school house was located where the Iuka Country Club now stands. The old school was moved and made a bath house for the swimming pool at the club for many years. Most

old photos of the school show students, which makes this photo of the large building very special.

According to the history of Snowdown Church, early school children were taught reading, writing and arithmetic in the Snowdown Church building. The earliest record found was recorded in 1858 with Mrs. Lydia A. Kirk, as teacher. A school record in 1921 is believed to be the last school taught at the church. A new seat of learning was built and the school was moved to where the County Club now stands. At that

time the school was only a short distance through the woods from Snowdown Church. The old road that many children in the community walked to school on is now gone.

In 1957, in an act of reorganization, the Iuka Separate School District and several adjacent districts were consolidated by the State Educational Financial Commission as the Iuka Special Municipal Separate School District, an area which included about 123 square miles. The old Snowdown School was closed and the elementary students were transferred to Iuka.

Students at Snowdown remember

with fondness Mr. Elmer and Lizzie Curtis who lived behind the school and had a small store. The children visited the store during recess and Danny Dexter could remember enjoying homemade popcorn and other treats. Another student, Jimmy McVay could remember he didn't always have the money for recess and Mr. Curtis would charge his purchase, knowing Jimmy's dad would pay on the weekend. Ms Lizzie died in 1980 and Mr. Elmer died in 1970. They are buried in the Johnson Cemetery at Unity Baptist Church not far from the school and their home and store.



#### Easy Almond Bars are a Favorite of Ours

by Pamela McRae

These Almond Bars make for a light sweet ending to Sunday dinner.

I love anything almond, so it was not a tough sell for me, but other family and friends who tried them gave them a "thumbs up," too! That's because their mouths were full of almond bar goodness!

These were very easy to make, and I had everything easily on hand in my pantry, though, I guess anyone who isn't as addicted to almonds like I am might need to make sure they had sliced almonds.

After baking, let them cool about

15 minutes and cut them apart; put the cut ones on a cooling rack to cool completely. Ice them while they are on the rack, but put a cookie sheet under to keep the mess to a minimum.

I think they would be a little more crunchy if you used a large rimmed cookie sheet that the recipe called for; I used a large casserole dish and mine were a bit cake-y, which I loved. It does make a large amount of bars! Enough to share at work the next day!

I altered this recipe and only made about half the glaze, because I don't love a ton of glaze. I'm glad I did! They would be too sweet for my bunch with a lot of sugary icing all over them.

#### **Almond Bars**

3 1/2 cups all-purpose flour 4 teaspoons baking powder

1/2 teaspoon kosher salt 1 cup unsalted butter, softened

2 cups granulated sugar

2 large eggs

1 teaspoon almond extract 2 tablespoons milk (any variety) 1 cup sliced almonds

2 cups powdered sugar 1/2 teaspoon almond extract 2 tablespoons milk (any variety)

Preheat oven to 325 degrees F. Generously butter (or use baking spray) on a half sheet pan (approximatedly 18"x13"). Set aside.

In a medium bowl, combine flour, baking powder, and salt. Set aside.

In a mixing bowl, beat butter and sugar until light and fluffy, about 3-4

minutes. Add in eggs and almond extract. Beat until combined. Slowly add in flour mixture. Mixing until well blended.

Press this dough into the bottom of your prepared baking dish. Use your fingers or a pastry roller to smooth the top of the dough.

Using a pastry brush, brush the milk to the top of the dough (you may not need to use all of it). Sprinkle with sliced almonds, pressing them lightly into the dough.

Bake for 18-20 minutes until done. You don't want to brown these bars.

Cool for about 15 minutes, then cut them with a knife into bars. If they are too soft to cut, allow to cool a little bit more. Carefully remove them to a wire rack to continue cooling.

Once cooled, you can make your glaze by whisking the sugar with the almond extract and milk. Drizzle over the bars and allow to set.

Blame your least favorite politician here, but my wife and I went to six stores in Florence and couldn't find a pair of cleats that would fit an average American child.



"We played a great game today and I'm proud of the effort," said Coach Jerry Long.






#### TC 13, Independence 1








