Population Shifts in County Push Redistricting

Due to population changes in the county, the five supervisor district lines are being changed.

There will be a public hearing April 29th, at 9 a.m. at the courthouse to discuss the changes, and to allow for public comment.

The courthouse has released a preliminary map and figures, showing the tweaks made to accomodate the ideal population per district of 3,957. The entire

Belmont Powerlifting is 2A State Runner Up

Iuka Increases Fines by Hundreds of **Dollars** for Failing to Clean **Up Property**

At the April 5th Iuka City Board meeting, the board voted to significantly increase fines for those who fail to clean up their property, in an effort to make a real difference in the appearance of the city.

"Before, the fines were minimal," explained Mayor Joel Robertson.

Now the fines start at \$100 for the first offense, \$300 for the second, and \$500 for the third, and any offense after, according to the amendments advertised.

And each day the offense is permitted to exist is a separate offense.

City leaders have been pushing for cleanup of individual properties, and there are several residents they are working with to get the junk cleaned up.

Iuka has recently started Keep Iuka Beautiful, to put the focus on city-wide beautification and they have a cleanup day scheduled for April 23rd.

The ordinance is enforced by Iuka's code enforcement officer and it goes into effect in 30 days, said Robertson.

Film Shot in Tishomingo County to Premier in Iowa Film Festival

Tishomingo County will sprawl across the big screen September 22nd, when "Mysterious Circumstance: The Death of Meriwether Lewis" makes its world premiere on September 22 at the Julien Dubuque International Film Festival in Dubuque, Iowa.

Shot in Tishomingo County and featuring local actors, the film has already received honors, and Director Clark Richey of Six Shooter Studios is looking forward to a warm reception from the first full audience to be able to view the film in its

entirety. "We are the featured film at the festival there this year, and we will see the film in the immaculate 600-seat Five Flags Theatre at 7 pm on Friday night. Certainly, we hope the film is well-received by a big audience. We are already one of three finalists for Best Feature Film in the festival. So, we feel good to know already that we know we have achieved some critical success with the Dubuque festival. In that sense, we hope to have a nice celebration of our project there."

Filming in Tishomingo County was important to the filmmaker from the very begin-

"When we proposed the

idea for this film, I knew I wanted to film it at least partially in Tishomingo County at [Tishomingo State Park]. That's always been a favorite location of mine, and its proximity to the Natchez Trace made it a natural fit. When we learned of the Butler Cabin at Bay Springs, we knew we had all the pieces of the puzzle right there in one

Richey was impressed with the hospitality of the area community and their dedication to the production.

'Of course, the challenges to filming centered around trying to accomplish our movie in such remote locations," Richey explains, "We had to use a lot of tents, generators and ATVs for sure. But the people at the State Parks both in Tishomingo and in Jackson couldn't have been more helpful... Robert Barske at the park was extremely helpful, and we sure appreciated it... The same goes for the Army Corps of Engineers who control the cabin at Bay Springs Dam. Jayson Adams and all the folks there went above and beyond to help us out from start to finish. We could not have made the movie without Jayson and that cabin — period. One challenge of shooting remotely like we did is finding housing

for our crew. We found a lot of help with that in Belmont at the Belmont Historic Hotel and Sparks B&B. We rented both of those properties completely for the duration of the project. It worked out great."

It was important to Richey

that local talent be utilized in the film. Reaching out to the county's arts council, Richey was able to fill two youth roles.

"Brent Bonds and the Tishomingo Arts Council helped us cast two local boys for the film — Rider Mayo of Iuka

and Keandre Wicks of Burnsville. We had an outstanding filming experience with both boys and their parents."

The Tishomingo Arts Council was more than happy to work with Richey and Six Shooter Studios to see the historic film come together. Brent Bonds of the Tishomingo Arts Council explains, "When Clark reached out to us, he asked us to make some recommendations on youth actors we knew. We were excited to help out and knew some young actors, but we wanted to be sure we were giving equal opportunity to those we may not have known about. With the cooperation of Farmhouse Restaurant in Iuka and Mary-Elizabeth Moore of Baytree Theatre in Red Bay, AL, we were able to hold an open casting call at the restaurant, which was a lot of fun for everyone, and a lot of new talent did come out in that. All those kids did a great job. Clark had told us he was fairly sure he almost had one of the roles filled but allowed us to field auditions for both. We had a kid come in, and he did such an amazing job, we told Clark, 'you really need to see this guy read,' and he ended up in the



film. It was gratifying to us to be able to make that connection."

Richey adds, "It was the first film for either boy, but they stepped up and did a good job with their roles. Tishomingo County will be quite proud of these two when they finally see the final product."

So, when will the film be viewable for people locally?

"We continue to work on securing distribution for the film in the US," explains Richey. "We have reached an agreement for a Canadian theatrical release and distribution in Canada with

Cinemas Guzzo of Montreal. Tentatively, our theatrical opening is set for September 16. We are in talks with a few US and international distributors, but for now, will continue with a short festival circuit until we can discern the very best fit for our film. We do hope to screen it in Mississippi mid-year at a special event in Jackson with the Mississippi Department of Archives and History. For just general availability, I'd say it would be watchable after our September theatrical release date."





county population is stated as 19,787 according to the map and figures prepared by the Northeast Mississippi Planning and Development District.

Chancery Clerk Peyton Cummings explained the reasons for some of the changes:

"Essentially, districts three and five remained about the same; districts one and two grew, and Fourth district lost population," he said. "Fourth district had to gain people, and there was not much way to gain from Fifth, so Fourth's lines were moved north along the east side of 25. Third district was adjusted to get some more of (relatively) population-dense Iuka."

A couple significant changes resulting from the new lines is that the Yellow Creek Port is no longer in the Second district, and in fact, Second district has no lakefront property any more; all the lakefront is in the First district. Also, the county landfill would

be in the Third district under the new plan. Second District Supervisor Nicky McRae has been handling the management of the landfill, explained Cummings, even though it was in the Fourth District.

Despite having the least population, Fourth district has the most area, and, accordingly, the most roads to maintain.


relatives.



Larry Norse Long

Larry Norse Long, 74, of Iuka, passed away on Wednesday, April 6, 2022, at North Mississippi Medical Center in Tupelo. Visitation was Sunday at Patterson Memorial Chapel. The funeral service was Monday, April 11, 2022, at Jones Chapel CME Church. Burial is in the Corinth National Cemetery.



He was born in Tuscumbia, Alabama to the late Hester Simms Long and Edward Obid Long. As a child, his hobbies were fishing, football, reading, and spending time with his mother. Larry married Alicetine Howard Long who is the mother of their two children. He attended Carter's Branch School, but graduated from Easom High School where he played football. He joined the United States Marine Corps, serving in Vietnam. He achieved the rank of Sergeant and served a four-year term. While enlisted he received a National Defense Medal, Vietnam Service Medal 2 Stars, Vietnam Campaign Medal Combat Action Ribbon, Good Conduct Medal and the Meritorious Mass.

After serving his country, he attended Northeast Junior College and Jackson State University from 1973 -1974. He received a BS degree in Political Science and a minor in sociology from the University of North Alabama. Larry retired from Tennessee Valley Authority as a public safety officer and Federal Agent for 28 years at multiple plants in the Alabama and Tennessee regions.

Downtown Iuka in the 1940s

This photo was among my mother's collectibles and it shows downtown Iuka looking east from Pearl Street. The first building houses the W. A. Holder Grocery. I was able to find one William A. Holder buried in the Holder Cemetery dated 1867-1956. This is possibly the owner of the grocery. The building later became the Iuka City Hall in the 1970s and today is O'Clair's Boutique.

The next building housed the Ed Johnson Motor Co./Iuka Garage. It was the future home of The Vidette/Tishomingo County News and today is being completely remodeled and preserved.

Next can be seen a small alley, which later became a parking lot for Iuka Baptist Church, and the two small buildings that are no longer there. One building says Joe's Café. The next large building is today Kim Borden's Friendly Florist. At one time it was Daisy's House of Fashions which had been the Mary Massey Shop in the 1950s. My mother, Daisy, always said her uncle Frank Bayliss and his wife Dimple had a café in the building. The Coca-Cola sign on the

front says Frank's Café. Frank Bayliss died in 1947, which means this photo was probably taken in the early 1940s or late 30s. Antique car enthusiasts can probably date the time.

The next two wooden buildings are no longer there. The news office received a photo from C. B. Reid years ago which looked like the old plank building and he reported that it was the home to *The* Vidette and he had worked there when

he was a young man. Today it is the lot containing The Front Street Café. The next building was rebuilt and became Cutshall Funeral Home and Furniture Store and today houses Grace and Mercy Hospice. On down the street, you can see the drug store, eventually Rushing Drugs, which was located where Faraway Places is located today and at the end of the block was Heitt's Grocery which today is Cream and Sugar Cafe.



Several weeks ago I ran a photo in Charlotte's Attic which was brought by the office by Norman Sullivan. It was the 3rd grade at Burnsville Elementary in 1961-1962. I have had several calls from readers helping to identify the students. Thanks to Tommy McAnally, Loretta Pardue, Talmadge South, and Theresa Cutshall for helping.



Giant NASA Barge uses Tri-State Port

On April 1^{st,} the port at Tri-State Commerce Park played host to a rocket transfer, from a regular barge to the Pegasus. NASA's barge, Pegasus was designed and built in 1999 to transport the

giant external tanks of the space shuttles. Pegasus is 310 feet in length and 50 feet wide, with the usable cargo deck length at 240 feet and 36 feet wide. The useable cargo deck height stands at 41 feet

For its massive size, the Pegasus has no engines; tugboats or towing vessels are required to move the barge. The transfer took most of the day and once loaded and secured, Pegasus and the rocket were on their way to their next destination.

Abuse Survivor Gets Day in Court Monday in Iuka; Accused Pleads Guilty to Fondling

A former youth minister in Tishomingo County has pled guilty to charges relating to the sexual molestation of a 10-year-old girl in the mid 1970's while he was the youth/music minister at the Iuka United Methodist Church in Iuka.

Seventy-four-year-old Dural Reece "Raggy" Ragsdale pled guilty to fondling Monday in Tishomingo County Circuit Court. He was indicted in 2019 on a felony charge of fondling a child under 14 for actions that happened when he was a seminary student living in the home of the victim's parents in Iuka.

Judge Kelly Mims sentenced Ragsdale to 10 years with Mississippi Department of Corrections, all suspended, conditioned on successful completion of 5 years supervised probation, and he must register as a sex offender.

According to the victim, Glenda Leanne Kay, now in her 50's, Ragsdale has "served over 40 years as a seminary-educated ordained Methodist minister throughout the state of Mississippi & adjoining states" including as director of the Wesley Foundation on the campus of Mississippi State University in the 1980's.

Kay was able to read a Victim Impact Statement in court Monday detailing the abuse suffered by her while Ragsdale was living as nearly part of the family. A masterful manipulator, her parents trusted him, and often the abuse happened as they all sat in the same room. Almost caught once by her father, Ragsdale packed up and left, but began threatening LeAnne by phone

so that she was too scared to report his

In 2015, she found Ragsdale operated a YouTube channel with suspicious purposes, and since then she worked with law enforcement and prosecutors to get charges pressed and stop him from abusing others. In 2019 District Attorney John Weddle and Assistant District Attorney Kyle Robbins took up her cause, and that resulted in the indictment and subsequent sentencing that happened Monday. With her family beside her in the courtroom, she thanked them for their service to the community in this matter.

"It's my hope that by telling my story it will give other victims the courage to come forward if they choose," said Kay.

Over the years, Easter has been "my" holiday for local family gatherings, so I've always enjoyed going all out for a beautiful meal, fancy table settings, and delicious desserts. I think it was because we had the biggest yard for hunting eggs for the five kids. We have a lot of happy memories of Easter at our home, and my kids would say we could not have Easter without this coconut cake.

Since the early days of our marriage, we always had Sunday dinner at Kirby's mama and daddy's -Alvis and Nelda McRae's - home. She prepared enough food to feed twice as many people than the 11 family members who actually came, and they ate on the leftovers all through the next week. They were both retired by the time I came on the scene - him from McRae's Grocery in Tishomingo and Nelda from being one of the favorite ever GEMS teachers at Tishomingo School, according to all the people who have extolled her virtues to me over the years.

Her Sunday spread featured no less than six different vegetables, plus a couple casseroles, at least one meat, and usually two packages of Pillsbury crescent rolls - as she had a grandson who sometimes only saw fit to eat rolls at Sunday dinner. The sumptious offering looked like some families' Thanksgiving meals, and any guests who came said so.

She also always had a dessert like a "chocolate eclair" made with pudding and graham crackers in a casserole dish, or pound cake, or pecan pie, or an endless parade of banana pudding

recipes made with increasingly "better for you" ingredients like sugar-free

instant pudding and fat-free Cool Whip (what self-respecting Southerner is

Even though she went through all this effort making Sunday dinner and pulling it off each week while also teaching Sunday School, and leading a women's ministry, me and her daughter (who would kill me if her name was in the paper - Marcia) were allotted ONLY one meal most years: Thanksgiving for Marcia, and Easter for me at my house. She always said "that's too much on you, I'll do it."

Of course, now, Nelda is at Southern Magnolia, letting people take care of her for a change. The kids are literally all over the country, so we may try to see if the dogs will hunt eggs, I guess. It's bittersweet for all of

I think the kids' mouths would still water when they think of some of her signature dishes and the chicken fingers she would cook just for them each Sunday, in addition to all the other great food!

The Cake

It starts with a cake mix, something I rarely do because I enjoy making things from scratch. The addition of sour cream and orange extract make a richer cake to base the whipped cream frosting on. You also must have frozen shredded coconut, no dried, sugar caked stuff for this

Add some pansies from your yard, and everyone is impressed.

Except my father-in-law, who always was puzzled why I would put flowers on the cake.

Easter Coconut Cake

1 pkg. Duncan Hines Butter Recipe Cake mix 4 eggs

1/3 cup vegetable oil

1 ½ tsp. orange extract

2 8-oz. containers sour cream

2-3 6 oz. pkgs. Tropic Isle frozen coconut

8 oz. whipping cream

2 1/4 cup(s) sugar, divided

Preheat oven to 375°. Grease and flour two 8" round cake pans.


