Iuka Board Opts In to Medical Cannabis; Changes Zoning Rules

Iuka's city board voted to "opt in" to medical marijuana in Tuesday night's meeting.

More than 25 people attended the meeting, including some who came to speak in favor of the board coming to this decision.

Mayor Joel Robertson explained that when the board voted last month to opt out of the new state-run medical marijuana program due to the ambiguous state regulations or lack thereof provided in the law signed by the governor, as did multiple municipalities across the state, it was not because they were against it, they just needed to see how the state was going to define the rules. In the last month board members had learned enough to reverse their initial decision, they explained.

"If anyone can make it through the hoops the state has established, who are we to deny them?" said alderwoman Emily Wadkins. She was referring to the substantial initial startup costs and fees associated, along with multiple rules the state has mandated. "


There are some things that as a city, Iuka is not prepared for. But to get this started and begin working towards this, all five facilities need to be opted in," Robertson said.

These five facilities include a dispensary (retailer), a research lab, a waste-disposal operation, cultivation in controlled growing facilities, and a testing facility. Once all five of these facilities are established, a dispensary is able to sell to those who qualify to receive medical cannabis/marijuana by prescription.

Supporters of this decision at the meeting gave strong arguments. There are many Iuka citizens with chronic pain and illness that would qualify to use medical marijuana, explained one citizen who said she suffered chronic pain. She said she had never taken marijuana, but if it was available and could give her relief, she was willing to try it. If people like her are traveling elsewhere to purchase this, Iuka could be losing out, because those people would likely shop wherever they went to fulfill medical cannabis prescriptions.

In other states, lines for dispensaries are out the door with customers purchasing this medical marijuana, said another citizen. The state, let alone the city of Iuka could possibly be losing a lot of money by opting out of having it

Board Approves Redistricting Map, Votes to Help Renovate TCDF Offices

The Tishomingo County Board of Supervisors voted Monday to adopt the new redistricting map with lines adjusted to accommodate population shifts in the county according to the 2020 census.

Last Friday the supervisors held a hearing attended by about a dozen people interested in the proposed change in district lines.

Concerns were raised by some about the relocation of lines, as they changed voting districts in ways some viewed as politically motivated. Some former supervisor candidates were directly affected by changes in the districts. Board members responded they simply adopted the lines as changed by the Northeast Mississippi Planning and Development District, who is contracted to do such work for the county, as well as other area counties. Board members also reported that the county's five districts plan to split evenly the ad valorem (property) taxes, instead of the taxes collected staying in the district where



The TCDF offices were last renovated in the late 1990s.



Senior Curt Carman Brings State Championship Home; Sets New State Record, Again

The state track meet took place on April 29th at Pearl High School last week and TCHS senior Curt Carman won gold in the 800-meter race, setting a new state record with a time of 1:58 -beating his own state record!

Three Tishomingo County High School athletes participated in the championships. Tag Hart participated in the high jump and finished 7th in the state. Ansley Ray ran the 3200m and finished 3rd in the state. Carman also competed in the 1600m and finished 2nd in the state. and also the 800m finishing 1st in the state. They are coached by Amanda Taylor.

they are collected. This has long been an issue - as, for example, the district (4th) with the most area and roads to maintain also has the fewest citizens, and therefore, less revenue.

The board voted to have Circuit Court Clerk Josh McNatt do the work to determine actual households and voting precincts affected by the district line changes at a proposed cost of \$7,000. This task would also determine who gets taxed under what district's property taxation level.

TCDF Office Renovation

The board voted to contribute about \$11,000 to renovating the Tishomingo County Development Foundation offices on Battleground Drive. The remainder would be covered by TCDF.

The former 1st American National Bank drive through location was renovated more

available here. It also was mentioned that there is a lot of available lands to start facilities on throughout the city of Iuka.

"The same devastating effects on our city and county were predicted with the legalization of beer and liquor - drunks in the streets, prostitution, etc. - or a state lottery," said Gwen Spain. "But here we are in the same peaceful small town, and the state is bringing in tons of cash with the lottery. There is a lot of money that could come into our town if we opt in to the regulated medical sale."

All this may be moot: the Tishomingo County board of supervisors has not even considered opting out, so the way the law is written, they have "opted in" to allowing it in the county.

Beer Garden Guidelines Adopted

The board voted to adopt a set of "beer garden"/ open container event guidelines, including opaque temporary fencing, as well as limits on location and time. Alderwomen Kay Perkins and Nancy Stripling stated they hoped people would understand that based on personal convictions, they were unable to vote for having a "beer garden" at all. The measure passed 3-2, with aldermen Johnny Southward, Emily Bell and Kenny Carson voting in the affirmative.

Related, the board voted to allow a Food Truck Festival at Jay Bird Park June 3rd. The festival will include multiple food trucks with different types of food, and a beer tent for those legally allowed to participate. Elizabeth Cummings is the organizer and was on hand to respond to any questions.

The board denied a request in April for this open container event to raise funds for the Iuka Boys and Girls Club, stating that it portrayed the wrong image for boys and girls to be involved. Cummings confirmed in written communication that, no "boys and girls" would be actually involved in the fundraiser.

Cummings presented a strong argument that a lot of similar programs in other cities now make most of their profit off of events that include alcohol sales. Fundraising is increasingly difficult and such an event could mean thousands more dollars being raised to provide funding for the program that provides free

after-school and summer child care for hundreds of local families

For example, her organization made a disappointing \$500 off a 5K fun run but expects to make much more at the food truck festival.

"It's a difference of making thousands or hundreds," she said, if you have this kind of event.

In a related issue, the board eagerly voted to reinstate a \$500 per month city contribution to support the Iuka Boys and Girls Club that had been removed from the city budget during the pandemic, and apparently, no one had noticed they never started it back up.

Changes in Zoning

In April the board voted against rezoning a local property from "R-1," a residential designation, to "C-1," a commercial one to allow the owners to operate a historic landmark home as a bed and breakfast.

Since that meeting, board members have been hard at work behind the scenes to produce a new "RI-1" zone, which would allow for approval/regulation of home-based businesses. The change will be advertised for 30 days in the newspaper, along with a revised advertisement for the aforementioned bed and breakfast proposal, and will be voted on at a zoning review meeting before the June meeting.

Cleanup Day Report

Alderman Emily Bell gave a report on the success of the cleanup Iuka day on April 22nd, stating that about 50 people participated and that the city greatly appreciated all the volunteers. She also reported attending the Keep Mississippi Beautiful state conference last weekend, and said it is a critical asset to be associated with the state and national organizations.

The mayor reported Taco Bell has started to begin building at the south Battleground Drive property and it is expected to be done in August of 2022.

Local residents asked the city about repairing a considerable pothole at the intersection of Eastport Road and Snowdown Road, and the mayor confirmed crews are addressing it.

Someone else asked about the perennial mess and standing water at the Eastport Street former location

of the Tacey Locke law office/old radio station. Robertson said that the city is pressuring landowner Charles Stafford to get power to the location installed and have a pump going to empty the water.

Zoning Commission Meeting

In a Zoning Commission meeting before the board meeting, the board discussed with landowner Charles Aldridge his residentially zoned property on Adams Street from which he runs a car repair operation. The goal of the city is that the property be cleaned up of cars that do not run, and several washing machines and similar items, in accordance with city ordinances, explained aldermen. Aldridge said he has taken several loads away for scrap metal, and is continuing to clean up. He was very agreeable to board members' requests to clean up, and have the location mowed.

The city tabled voting on his request to be rezoned to a commercial designation, in hopes they could continue negotiating an agreement in the way he operated his businesses, possibly relocating some of his storage to a non-residential location.

The year was 1977. I have a vague memory of sitting on a shag carpet floor. I'm six years old and everything is orange, yellow, or that avocado green color that was the rage of the 1970's. There is a television on a piece of furniture that serves as a stereo console with built-in speakers that is the size of a small truck and weighing twice as much. There were either four or five VFH TV channels available depending on the weather and direction of the antenna. I was the remote control. There were a few UHF channels that most people didn't bother with because it took a combination of two knobs and there was mostly just weird stuff on those channels anyway. Those channels came in handy on Sunday morning, though, because that's where you could watch semi-local professional wrestling while getting ready for church. Watching Jerry Lawler fly off the turnbuckle onto someone's head before a Sunday school lesson on peace just seemed like part of the getting ready process in those days.

I envision my six-year-old self looking up at the TV and watching the news reporter openly mourn the untimely passing of The King. Elvis had fallen from his throne. The King was dead (or relocated to a cabin at Eastport where he lived out his days in anonymity, depending on who you ask). During

the broadcast a commercial break grabbed my attention. There was an Indian paddling a canoe through garbage and pollution-infested waters. He pulls the

canoe out of the water onto the oily,

litter-strewn beach and dramatically sheds a tear when trash is thrown at his feet from a passing car. The loss of The King, along with the crying Indian with trash around his feet, was almost more than my little heart could bear. I remember my youthful, innocent self thinking how real and honest and decent the Indian must be, and how simple and unanimously-accepted his message would be if only everyone else saw what I was seeing on that tiny television screen that seemed so large at the time.

Years would pass and the Indian would die. Like Elvis, we would learn that the circumstances of his life were not quite what they appeared on the surface. It would turn out that the Cherokee Indian in the commercial was an Italian actor named Oscar DeCorti who was born to Italian immigrants in Louisiana. Not even the tear was real. It was made of glycerin and the actor "Iron Eyes Cody" didn't even want it in the commercial.

He stated that a proud Native American would never be seen shedding tears (which is quite a presumptuous thing to say for an Italian). He was later convinced to add the tear by Lady Bird Johnson for dramatic effect. The message was on point, but the delivery was a sham. As with the Italian Cherokee, the real circumstances of Elvis' life were a far cry from the public image we all so desperately wanted to hold on to. But it was not real. The truth was lain bare on the bathroom floor, and no amount of public relations spin could hide the fact that the one thing bigger than The King was his drug addiction.

My older self knows some things that my six-year-old self could never have been able to comprehend. One of the lessons we learn only with time, and usually a couple of hard knocks, is that nothing on this Earth is exactly as it appears on the surface. Taking anything at face value today is the luxury of six-year-olds in a world full of biased information flying from every direction. As 24-hour targets of a multi-faceted information war for our hearts and minds, it is imperative that we don't lose the message because we like the package its alternative is delivered in. We must never lose sight of the fact that a lot of those tears out there are made of glycerin.





Old Vidette Building was a Garage

As the former home of The Tishomingo County News and The Vidette is being completely remodeled in downtown Iuka, I spend lots of time looking for old photos of the original building. A few years back Jackie Wiley (now deceased) brought an old photo by the office that was probably the oldest photo ever taken inside the building when it was a garage (possibly in the 1940's). I have heard rumors that at one time the building was even used as a theater for silent movies.

This photo shows Clara Gravette Woodley and Carlton Leslie Woodley, owners of Iuka Motor Co, and Web Wiley, mechanic as he works on cars in the old building. The date of this photo is not known, but Mr. Woodley and Whit Fairless were the first automobile mechanics in the county. In 1919 Carlton Woodley became agent for Briscoe automobiles. In 1923 he acquired the dealership for Dodge Brothers automobiles and Graham Brothers trucks. He later became a Chevrolet dealer, owning and operating the Iuka Motor Company until his retirement in 1959. (As a child I remember the Chevrolet dealership which was located between Hodge Antiques and Lil' Smokies on Hwy. 72.)

According to an article written by Margaret June Woodley Riley and printed in the Tishomingo County

History and Families book, Carlton Woodley was born in the Prospect Community on Oct. 28, 1896 and moved to Iuka in 1908. Mr. Woodley worked as an errand boy for a newspaper known as the Tishomingo County Pantagraph. It was here that he learned to set type by hand. His father, Bob Woodley, would take freight car loads of cattle to St. Louis and on one of these trips, Carlton went with him. It was there that he saw and fell in love with the first automobiles – dealing with automobiles would be his lifelong profession. When the first T-Model came to Iuka, he was among the first to learn to drive. He drove for the late Dr. A. F. Whitehurst and the late Dr. A. H. Montgomery long before

they discarded their horses and buggies and drove over roads that were almost impossible.

I want to thank Mary Wiley and her daughter Deborah Lambert for locating this photo for me to share with our readers. Web Wiley was well known in Iuka for his mechanic skills and worked for Mr. Woodley for many years. He was the son of Samuel Wiley, who came to Iuka from St. Clair County, Illinois and worked in the gravel pits near Iuka. Samuel married Edna Alice Wingo in 1902. Their son William Webster (Web) Wiley married Eula Hubbard and raised four children, Billy, Jackie, Betty, and Barbara Ann. Web was born in 1903 and died in 1992.

Amish Macaroni Salad

- 2 cups uncooked elbow macaroni
- 3 hard cooked eggs, chopped
- 1 small onion, chopped
- 1 small red bell pepper, seeded and chopped
- 2 cups mayonnaise 3 tablespoons prepared yellow mustard
- $\frac{1}{2}$ cup white sugar
- 2¹/₄ teaspoons white vinegar
- ¹/₄ teaspoon salt
- ³/₄ teaspoon celery seed





There are currently over \$80 billion federal dollars available to Mississippi, but we have been unable to access them, due to a lack of matching funds. Thanks to the Legislature, this new Trust Fund will allow our state to multiply our investment with other funds and utilize


a small portion of this \$80 billion for recreation and conservation.

Establishment of the Mississippi Outdoor Stewardship Trust Fund will support our economy and create jobs. As a group, outdoor enthusiasts in the state spend an average of \$6 million per day (\$2.2 billion annually), supporting \$847 million annually in salaries and wages for the 33,584 jobs this sector creates for hard-working Mississippians; supporting \$186 million annually in federal taxes; and supporting \$187 million annually in state and local taxes. All of this has a ripple effect of \$3.02 billion annually, all according to the Congressional Sportsmen's Foundation.

Mississippi is a global leader in design and manufacture of outdoor recreation products. Growth in the outdoor industry is creating a demand for highly skilled workers. In short, outdoor recreation is a growing and diverse economic super sector that is a vital cornerstone of successful communities in Mississippi and cannot be ignored. Most impor-

as leaders across the country recognize the undeniable economic, social, and health benefits of outdoor recreation and the products that support it. This Trust Fund, combined with the strong business climate that Mississippi provides, will allow this business and industry sector to continue to thrive.


The Legislature did not allocate dollars to the Trust Fund with a reoccurring revenue source such as a diversion of tax dollars from the existing sporting goods sales tax-which is the provision used to fund tourism efforts in the state. Instead, the Trust Fund is based on annual appropriations, beginning with \$10 million this year.

Mississippi may not have it all. But

we do have some of the best natural resources anywhere in America and our state's leadership is passionate about conservation. We sincerely thank the Mississippi Legislature for helping guide this valuable legislation into law. But it doesn't stop here; we need to keep improving this law so we can capture a larger part of the \$80 billion available to Mississippi. Let's use this new Trust Fund and our state's wealth of natural resources to lift Mississippi up and help address many of our state's problems. Our future depends on it.
