
Baptist Church.

It's time to mend some fences, literally, on **Turnpike Mountain Road**

As we try to do hard-hitting news here at the Tishomingo County News/The Vidette, it's time to address an issue that is stampeding through local Facebook conversations. Dozens of people have weighed in on it... that's right: the loose cows on Turnpike Mountain Road.

Actually ON the road, not inside their fence. Local law enforcement has confirmed that a few times every week they respond to calls regarding cows walking loose on Turnpike Mountain Road - now commonly referred to as Cowpike.

There are photos posted daily of cows cheerfully chomping grass along the right of way, along with warnings to local motorists urging caution.

Apparently, not much consideration is being given to the "urging caution" part. When asked, one resident said they had never seen a speed limit sign on that road, and cars and motorcycles go "60-70-80" miles per hour along the twisting two-lane county road. For future reference, unmarked county roads have a speed limit of 55.

Residents along the road say there are bulls, cows, longhorns, and calves participating in this bovine rebellion against fences. They are usually along the right-of-way, where, of course, the grass is always greener, but they do move to the other side of the road, where surely, the grass is even greener. The cows seem to have little respect for traffic, naturally, and even less respect for a gate that is reportedly "leaning" in place.

Having experienced a driver colliding with a small draft horse of our own on our road, the editor can assure you it is no small thing to experience a car-livestock collision, for either the livestock or the vehicle. Most times the lives of both are seriously at risk. If it only seriously injures and doesn't kill the animal, you may have to wait for a vet to humanely end its suffering, if there is not someone nearby to help with that - all terrible options.

Most vehicles fare similarly when colliding with something weighing 1,000 to 2,000 pounds. The livestock owner has liability if something happens.

An officer said the owners claim the cows jump the fence at will.

It may be time for Turnpike Mountain residents to purchase a "Cow Crossing" sign to warn motorists, but it's doubtful the cows are going to respect that, so it remains a danger until some serious fence repair is accomplished.







"The real beauty of this evening," said TAC Chair Brent Bonds, "is seeing the efforts of the past two years come together for the first time. Having worked mainly with digital programs on account of COVID, we've built a very wide community of artists from across states, and it was something really worth celebrating to see these people come together physically inside of Tishomingo County for the first time. May 2022 Wild Hog Control Program Application Period Ends May 16th

The Mississippi Department of Agriculture and Commerce (MDAC) is now accepting a new round of applications for its Wild Hog Control Program (WHCP). The application period will close on Monday, May 16. All Mississippi counties are eligible for the application period. In Mississippi alone, wild hogs cause more than \$60 million in damages annually.

Through the WHCP, MDAC provides "smart" wild hog traps to landowners and managers for the control of wild hogs on private agricultural and forestry lands in Mississippi. MDAC provides the training necessary to use the "smart" traps and technical guidance regarding the most

"The next trapping period will occur during the early months of summer which is normally a very successful time for trapping wild hogs. I urge farmers and landowners that are impacted by these nuisance animals to submit an application," said Commissioner Gipson. "Use of the traps is free of charge; however, users must supply bait and labor to use the traps."

Applications must be completed and submitted online at www.mdac. ms.gov/whcp. Submitted applications will be evaluated based on the number of acres available for trapping, historical agricultural losses caused by wild hogs on the property, and current trapping efforts on the property. A cooperative application is encouraged for small acreage (i.e., adjoining land managers of small parcels should work together to submit one application). Traps will be available for one-month intervals, dependent upon use and success. One trap per 500 – 1,000 acres is

recommended, depending on the landscape and land use.

Beautiful Banana Pudding Reminds Us of Old Friends

My friend, Sharon Stegall of Iuka sent me some mouthwatering photos of a banana pudding she made recently to celebrate several successful months on a diet.

"I've been on a strict diet since January, trying to drop some pandemic weight," explained Sharon. Like others, she started cooking more at home during Covid isolation. "We had extra bananas at the house, and I looked up an old favorite *Southern Living* recipe for banana pudding and had good results."

With friends like Jean Crane, who makes a todie-for banana pudding even we at the *News* have heard about, making a banana pudding can be intimidating, said Sharon. But she was pleased with the results and even has some tips to make it a little easier.

Sharon said it was easier for her to do the pudding cooking part of the recipe in the microwave, watching carefully and stirring occasionally. Once it thickens, she added the vanilla and butter.

She also suggests

adding ¹/₄ teaspoon of cream of tartar to the meringue, which helps it hold up and not to weep.

The vintage cornflower Corning ware bowl pictured was from the kitchen of a longtime friend, Olivia Jones, with whom she and other quilters from the Needle Chasers Quilt Guild had many an adventure. From quilting workshops to trips to quilt shows and retreats, Olivia was always fun. I particularly remember her telling of a visit to a topless beach... and I'll not say more. Sharon was given the bowl by Olivia's daughter after she died, along with much of Olivia's stash of quilting fabrics.

Writing this has me thinking of searching for Olivia's chicken salad recipe, which was one of my favorites! I remember it was written on a red file folder during a quilt show a long time ago. But until then, I'm determined to try this banana pudding recipe when I get some time.

Banana Pudding

- 1/2 cup sugar
- 2 tablespoons cornstarch
- 1 teaspoon of salt
- 2¹/₄ cups milk
- 4 large eggs, separated
- 2 tablespoons unsalted butter
- 1 teaspoon vanilla extract
- 3 1/3 cups vanilla wafers
- 4 ripe bananas, sliced
- 3 tablespoons sugar

Preheat oven to 375 degrees. Whisk together first three ingredients in a small bowl. Whisk together sugar mixture, milk, and 4 egg yolks in a medium-size heavy saucepan until well blended. Cook over medium heat, stirring constantly, 6-8 minutes or until thickened. Remove from heat; stir in butter and vanilla.

Layer half of vanilla wafers in an 8-inch square baking dish. Top with half of banana slices, and half of pudding. Repeat procedure with remaining banana

slices, wafers and pudding.

Beat egg whites at high speed with an electric mixer until foamy. Gradually add three tablespoons sugar, beating until sugar dissolves and stiff peaks form. Spread meringue over pudding, sealing to edge of dish.

Bake at 375 degrees for 7-10 minutes or until golden. Let cool 30 minutes, and serve warm; or chill an additional hour, and serve cold.



Head volleyball coaches at both Belmont High School and Tishomingo County High School will be paid supplements comparable to the basketball programs if the board approves proposed coaching supplement increases at the June School Board meeting.

During the school board meeting Monday, May 9, Fifth District Board member Stacy

Stepp explained that volleyball coaches put just as much time and effort into their season as basketball coaches and also touched on the success of volleyball programs at both high schools. If approved, the supplements would be \$5,500 for the head coach, \$2,500 for the assistant coach, and \$1,250 for a

junior high coach at each junior high school.

"These programs are growing," said Superintendent Christie Holly. Both volleyball programs at BHS and TCHS have developed strong programs since they started in 2012.

Belmont VB State Champions 2021

Under Coach Stephanie Cleveland for the past 6 years, the Lady Cardinals are 2021 State Champions and have made three State appearances beginning in 2019. Cleveland is assisted by Coach Anna Brooke Wooten. Cleveland was the 2021 North All-Star Coach and NEMVCA (Northeast Mississippi All-Star Volleyball Game) Coach. She's had two players go on to play in college; Kate Greene at Blue Mountain and Maggie Ledbetter at Mississippi University for Women.

The Tishomingo County Lady Braves are coached by Division 1-4A Volleyball Coach of the Year, Brian Middleton. Middleton led the Lady Braves to the playoffs in the 2021 season.

A key part of the board's decision was to provide a \$1,250 supplement for a junior high coach at all four junior high schools, as many other districts have.

"Junior high interest is exploding," said Cleveland. "Every time we schedule a game, they ask if we have a junior high team that can also play theirs. That will help and "I think it's exciting that volleyball is getting pushed in our county!" said Middleton. "I think our student-athletes deserve every opportunity they can get to be successful. This will definitely help us develop our younger kids."

Cleveland pointed out that Northeast Mississippi Community College is adding women's volleyball to it's athletic program this year, too.

Raising the volleyball head coaches' supplements will be officially placed on the agenda and voted on at the next school board meeting.

Cheer Issue Addressed

Also on the agenda was a proposed new coach for TCHS cheer, a program that has experienced significant controversy since spring break. The board denied the proposed candidate, sending the decision back to the school, who will need to post the position again, said Stepp, who made the motion to individually consider that position out of 39 other personnel proposals. Kayla Smith (TC State Championship squad 2010) was approved as assistant cheer coach as part of that long list.

Since 2010, TCHS cheer has been 4A Mississippi State champions several times, and runnerup state champions a few times as well. During that time, they were coached by Beth James and Chasity Moore, and then Amy Webb and Beverly Butler.

Northeast Serves Up Volleyball as Newest Athletic Offering

BOONEVILLE, Miss. - One of the fastest growing sports in the Magnolia State is making its way to Northeast Mississippi Community College.

Northeast is starting a women's volleyball program to its lineup of athletic offerings. The Tigers will officially begin head-to-head competition during the fall 2023 semester.

"We're happy and looking forward to providing volleyball for studentathletes in our district and also the entire state of Mississippi," said Northeast president Dr. Ricky Ford. "With so many K-12 schools adding volleyball, this will allow all those student-athletes a chance to continue their experience on to the collegiate level."

The Tigers will be classified as a Division II affiliate of the National Junior College Athletic Association (NJCAA). Northeast will contend for berths to the national tournament inside the NJCAA's Region 23 and Gulf District.

Northeast is one of only five members of the Mississippi Association of Community Colleges Conference (MACCC) to sponsor volleyball. The sport is not sanctioned by the MACCC at this time.

Itawamba Community College, Northwest Mississippi Community College and Pearl River Community College have each fielded volleyball teams for less than five years. Jones College recently announced its intentions to add the sport as well.

This increases the total number of athletic programs at Northeast to 11. It is the fourth addition in the last two academic years along with men's and women's tennis plus co-ed archery.

Northeast also proudly boasts successful baseball, men's and women's basketball, cheerleading, football, men's golf and softball programs with firstclass facilities for each sport.

Historic Bonner Arnold Coliseum will serve as the home venue of the Tigers. Volleyball lines and the sleeves for the nets were added to the main court during the summer of 2021.

The regular season for volleyball in the NJCAA begins in mid-August and concludes with region and district postseason tournaments that run from late October into early November.

Volleyball is increasing in popularity locally. All but one of the high schools in Northeast's traditional five-county service area will offer the sport during the upcoming 2022-23 academic year.

In addition, in-district schools Alcorn Central, Belmont, New Albany and Walnut have either won or played for Mississippi High School Activities Association (MHSAA) state championships over the last three years.






