Groundbreaking IMS House Program Builds Unity, Belonging for All Students

Monday was House Cup day at Iuka Middle School, marking the culmination of a year of activities for the eight "Houses" that have provided students with positive behavior reinforcement for the past three years.

Integrita House, led by "House Mother" Brooke Nunley was the winner this year, so their signature red color was the color for EVERYONE to wear, even if you were a member of one of the other seven houses, explained IMS Principal Chrystal Smith, who helped institute the House program at the beginning of 2019. "On House Cup Day, all of IMS's houses unite to wear the winning house's color, and there is a celebration for that house," said Principal Smith. Each of the eight houses includes students from each of the $5^{\text{th}},\,6^{\text{th}},\,7^{\text{th},}$ and 8^{th} grades, and they stay with that house through their IMS years. Points are awarded to both individuals and houses for positive behavior demonstrated throughout the year, and the House with the most points wins the House Cup. Individuals in all the houses who have

earned the most points also are recognized on House Cup day, which also includes lots

of fun (point free) competitions for everyone.

How it Started

The primary purpose for starting this was to give every kid something to believe in and belong to at school, and to unify the $5^{\text{th}}/6^{\text{th}}$ -grade and

inspired by how they use their house system there, and I have heard Ron Clark speak and have read his books," continued Smith. "That and my love of the Hogwarts houses made me an enthusiastic advocate for the program. I presented the program as a sort of PBIS (positive behavioral interventions and supports), and Jeremy Reece, then principal, secured funding for our house points app." They formed a group of eight who would be the first leaders of the houses, and began planning that summer. New Supervisor Sworn In Monday

Eric Booker was sworn in as Tishomingo County's newest county supervisor Monday morning, to serve an interim term until a special election in November.

With his wife, Heather, and children Ashley, Madelyn and Sean beside him, Booker took the oath of office in the company of several co-workers and guests in the Tishomingo County Courthouse courtroom, and will begin serving as First

District Supervisor immediately in place of Brandon Grissom, who died last week after an extended illness.

Board members said that Grissom had indicated his desire for Booker to take his place weeks ago, and the Board approved his appointment last Friday.

Eric Booker, 43, has been with the First District since October 2012, and has worked as Grissom's "right-hand man," according to Board President Michael Busby.

A special election will be held November 8th to fill the unexpired term of Brandon Grissom, who died last week while serving as First District Supervisor.

The person elected in the non-partisan election will serve approximately 14 months to finish the term of Grissom.

Deadline to qualify as candidate for this race is September 9th, and qualifying starts August 10th, when prospective candidates can pick up the qualifying paperwork at the Circuit Clerk's office.

It's a non-partisan election, in accordance with state law. Candidates will not campaign with any party affiliation.

Qualifications to run for supervisor are:

- Never having been convicted of a felony, unless pardoned for the offense (bribery, perjury or other infamous crime punishable by a minimum of one year in the state penitentiary
- Being a qualified elector of the county and a resident for two (2) years, as of the day before the election in the district in which he/she seeks election.

Construction Starting on New Pavilions at Mineral Springs Park

The City of Iuka is continuing with upgrades to Mineral Springs Park with the addition of two handicapped-accessible 20' x 30' A-frame outdoor open pavilions.

These will be similar to the picnic pavillions at Tishomingo State Park, but they will have restrooms, too, explained Mayor Joel Robertson.

One is being built in the northwest section of the park and the other is being built in the southeast section of the park. Each will have a concrete floor, lighting, electrical outlets, an earthtone color metal roof, and a male and a female ADA accessible restroom on the back. The pavillions will be about \$15,000 each, said Robertson.

Both pavilions are currently under construction.

"These new additions to Mineral Springs Park will create new opportunities for visitors to enjoy and utilize the park, while creating lasting memories for many years to come," said Mayor Joel Robertson.

leaders, and these people are crucial to the survival of the house system.

"It takes every adult in the building creating bonds with kids for it to work," said Smith. "We have had a lot of positive support from the parents as well. As we move beyond Covid, I look for them to be able to help us more for House days."

"It creates a sense of belongingness and togetherness for the students, especially for young ones not involved in clubs, band or sports, who have not yet found their niche," explained Smith. "It gives them a home inside of school."

They had their first sorting day in the fall of 2019, and even though Covid cut their plans of awarding a House Cup that first year, administrators learned that good planning upfront allowed them to be very adaptable. And they learned that the students are resilient.

How it Works

There are 8 Houses with about 40-45 student members, and each has a character trait that is valued both at school and in the community.

- Credo- perseverance
- Mkali- illumination/positivity
- Makiramy- empathy
- Meraki- creativity
- Integrita- integrity
- Synergi- synergy/teamwork

• Teenima- generosity

There is one House Staff Leader, affectionately known as the House Mother or House Father. All but one House is represented by the House's founder. Each house has a Prefect: an 8th-grade student who exhibits leadership qualities, and enthusiasm for their House's success, and is selected by House faculty.

All other faculty and staff are divided among the eight Houses. These staff members serve as trusted adult mentors for House members. All students are assigned a mentor; for younger students, that may be a seventh or eighth grade House "sister" or "brother." Mentors across grade levels (ex. 8th grader with a 6th; and a 7th with a 5th) help to create a sense of belonging and unity. A family is created.

Effect on Students

"I think it's been very successful and positive, and the team has made it work through the very worst of times, and that has been great for the students," said Tishomingo County Schools Superintendent Christy Holly. "They have adapted it to work for IMS, and it's a great program."

Students, even those who aren't competitive by nature, enjoy earning points for their Houses, administrators

report. While they cannot ask for points, one can easily see the recognition click, "Hey, if I want to get points, I really need to kick it into gear in math class today," or "I really could help the custodian during my enrichment class since I'm caught up on my homework." They award points to students who volunteer to do these things, but for the young, reticent students, they will sometimes pick them for different tasks to show them how they receive points.

"It helped me try harder in class because I wanted to win points for my House, and I didn't want to let anyone down," said Kylon Goodloe, Synergi House prefect in 2021. "I also wanted to show that I could be a good leader. The houses let me do that. It helps younger kids work hard toward being a prefect. I tried really hard in seventh grade. It helps you to meet more people, and have more friends you wouldn't have without it. It helps the quiet kids get out of their comfort zone. It gives all of us a chance to participate in something and something to look forward to like house days."

This race has no marked finish line and no identifiable beginning. The length of the course is yet to be determined, there are no judges or officials, and there will be no champagne or congratulations at the end. The finish line is the ground, and the winner gets to fly face-first into it at maximum terminal velocity, followed shortly by all other contestants. We have been recruited into a contest that no one can win. We are in a race to the bottom.

I can't tell you exactly when it all started, but it seems to have involved Newt Gingrich and a plot to blow up politics as we knew it by manufacturing hate and discord between the two major political parties. The goal was to reinvent the United States House of Representatives using the old, wellknown technique of divide and conquer. Before we can encourage people to hate

New Report Shows Fifty Percent of College Grads Not Working in Mississippi Three Years Later

As of 2020, only half of all Mississippi's public university graduates worked in the state three years after leaving college. Further, according to a report released by State Auditor Shad White's office, data trends show a growing number of college graduates choose to leave Mississippi as time passes. If the trends continue without being addressed, Mississippi's "brain drain" is likely to worsen even as the state spends hundreds of millions of dollars each year on its public universities.

"This is a critical issue for Mississippi. As State Auditor, I wanted to understand how much we're spending on university students and how many are staying here," said White, "but as a Mississippian, I'm concerned about more than just the cost to taxpayers."

In addition to showing the percentage of businesses? Will grandparents be able to see their grandkids grow up?'" said White. "These questions show why brain drain is important to everyone."

The report was produced after State Auditor Shad White requested data from the State Longitudinal Data System (SLDS)—a state-funded resource designed to evaluate workforce and education strategies in terms of real outcomes, such as entrance into employment, wages, and skill gains.

Chicken Ring Fancy Enough for Sundays, and Flexible Enough for Weeknights

This chicken ring is a great summertime meal - easy, but fancy enough to serve at Sunday dinner.

I first had this at a Pampered Chef party hosted by Angela Gresham Simpson, long before she was one of our county's best caterers and the proprietor of Cedar Creek Ranch event venue. It was so good she sold me on my pizza stone, which we still use regularly.

You don't have to make this in a ring shape, but it makes it special. I believe in fully committing to cooking if you are going to do it. Though its fine for other people, I don't look for the easy way to do things, and I nearly always use real ingredients. This recipe, using crescent rolls, is about as far as I go using a premade item, instead of making pastry from scratch, for example.

Be careful to get the original crescent rolls! This would not be the same with the honey or garlic ones they make now!

I used to always cook the chicken myself, but we really like getting a couple smoked chicken breasts from Brooks Grocery and using them to make the chicken salad. You can vary the chicken salad any way you like, and at this point, I have to mention that my husband, who is super-adventurous in the kitchen, always suggests putting artichoke hearts in this, and it is really a nice addition.

Enjoy!

Chicken Ring

2-3 chicken breasts, cooked and chopped mayonnaise

3 tbs. Dijon mustard

1/2 cup mozzarella cheese

2 pkgs crescent rolls

1/2 cup onion minced

1 green pepper, cut into strips

1 thinly sliced tomato

If cooking your own chicken: Place chicken breasts in pot, covered with water. Add salt to the water, along with any other seasonings to help flavor the chicken. Bring to a boil and then turn to simmer for about 20 minutes. Remove from water. Let cool. Chop into small cubes.

Preheat oven to 375°.

Combine in a bowl the chicken, onion, cheese, mustard and enough mayonnaise to make consistency of a chunky chicken salad.

Place crescent rolls in a star/ring shape as shown. You might not have to use all the rolls. Press the area where the chicken salad will be placed to a uniform thickness, to ensure even cooking.

Spoon chicken salad in a ring over the widest part of the rolls. Place tomato and pepper strips along the top. Fold pointy ends of rolls into center, pinching it together where it meets the widest part of the roll, forming a ring. There should be some chicken salad showing.

Bake at 375° about 15-20 minutes, until rolls are nicely browned and it gets done on the bottom, too. Serve warm.
