Sales Tax Holiday this weekend for back to school shopping

This weekend, back-toschool shoppers can take advantage of Mississippi's statewide sales tax holiday when they buy clothes, shoes or school supplies.

According to the Mississippi Sales Tax Holiday passed in the 2009 Legislative Session and amended in 2019 Legislative Session, Sales Tax is not due on the sale of articles of clothing, footwear, or school supplies if the sales price of a single item is less than \$100.

The 2022 Sales Tax Holiday takes place between 12:01 a.m. Friday, July 29, 2022 and Midnight Saturday, July 30, 2022

Definitions

"Clothing" is any article of apparel designed to be worn on the human body including pants, shirts and blouses, dresses, coats, jackets, belts, hats, undergarments, and multiple piece garments sold as a set.

"Footwear" is any article of apparel for human feet except for skis, swim fins, roller blades, skates, and any similar items.

"Accessories" as jewelry, handbags, luggage, umbrellas, wallets, watches, briefcases, and similar items do not qualify for the Sales Tax Holiday.



Tishomingo State Park named #6 in Top 10 parks for camping in USA

Tishomingo State Park, one of the best known treasures of Tishomingo County has been recognized as one of the ten best state parks for camping in the entire country, according to a story this week in USA Today.

According to the story, "the United States is home to more than 10,000 state parks, attracting more than 700 million annual visitors. As more and more travelers seek the open road and open spaces, those numbers have continued to grow."

To find the 10 best state parks for camping, a panel of experts partnered with 10Best editors to pick the initial nominees, and the winners were determined by popular

New RV campground improvements

By September, 25 of the

Park's RV campsites will be upgraded, when a \$1.1 million project is completed.

Campsites number 38-62 are being refurbished to feature newly poured, larger concrete pads, upgraded power connections, and new picnic tables and grills at each site. The pads were 10 feet by 30 feet, and now are 10' x 45'. Additionally, the sites are graded to be more level, and three are handicapped accessible.

Before the project, if you stepped off the camper pad, you had to step down, often quite far, the surrounding ground had washed away so badly over the decades.

The renovated sites are the ones furthest down the campground road, to the west and north side of Haynes Lake, where campers fish, canoe, and watch local ducks and geese.

Pads 1-36 are still available to rent, ensured Barkse,

throughout the construction period.

The campground renovations were designed by local engineering firm Dean McRae Engineering, and the contractor on the site is Cook and Sons.

The Park averages 73,000 visitors a year from all over North America and beyond.

New traffic signals set to turn on August 2nd

Area drivers are urged to be aware that the new stoplights on Highway 25 will be activated next Tuesday.

Stop lights at Battleground/ Heritage Drive and Old Highway 72/Quitman will become full stoplights as part of the multi-million improvement project Mississippi Department of Transportation has been working on since early spring 2022.

For decades Iuka has been a one-stoplight town, with Tishomingo County's only stoplight, so on a 55 mph section of Highway 25 there are bound to be some near-misses for folks seeing the full-stop redlights for the first time.

Add to that the upcoming opening of Taco Bell on Battleground Drive, within sight of one of the stoplights, and that nearby intersection may be dangerous for a few weeks as motorists adjust.

The \$5.7 million in improvements are part of an overall safety improvement



plan for about 36 miles of the two-lane main artery through the county – from the Highway 350 intersection in the north to nearly the Itawamba County line south of Belmont.



Sales tax holiday, continued from front

items that are commonly used by a

student in a course of study.

Eligible and non-eligible items The Sales Tax Holiday will apply statewide to all consumer purchases of clothing, footwear, and school supplies with sales prices of less than \$100.00 per article during the Sales Tax Holiday. The tax holiday does not apply to sales of any other items not defined as clothing or footwear. A list of eligible items is provided in this guide.

Guidelines

\$100 Threshold. The Sales Tax Holiday applies to each eligible item selling for less than \$100.00, regardless of how many items are sold at the same

Items priced at \$100.00 or more are subject to Sales Tax at the regular retail rate of 7%

For example, a customer purchases two (2) shirts at \$50.00 each, a pair of slacks at \$75.00, and a pair of shoes at \$110.00. No Sales Tax is due on the sale of the two (2) shirts and the pair of slacks at a cost of \$175.00, even though the combined cost exceeds the one hundred dollar (\$100) threshold. However, Sales Tax is due on the entire \$110.00 for the shoes since they exceed the one hundred dollar (\$100) threshold.

Mississippi Department of Transportation performed a safety audit of the entire Highway 25 corridor prior to the resurfacing work that was mostly completed last year, according to MDOT District Construction Engineer Jamie McDonald. Based on Department of Public Safety accident data from the past 5-10 years, and the engineering team's survey of the highway, they identified about twenty-nine locations that needed improvements to enhance safety for the thousands of cars, buses, trucks and tractor trailers that use the road daily.

It's the last day of summer before she starts kindergarten. She has the Jack Sparrow backpack. She has the new glitter sneakers. She's ready to fly but I find myself wanting to wrap my wings around her, hold her closer for a little while longer. The first day of school I walk with her hand in hand down the long kindergarten hall. Her classroom is the last room on the left. I slow down on purpose. She lunges ahead tugging my hand, "Come on, Mama, they're waiting

Shouldn't it be easier that she's ready? She finds her seat and waves at me as the teacher closes the door. I make it halfway down the hall before I turn and run back to her classroom. My

reflexively and instantly change the channel. I did change the channel, but only after listening to what can only be described




The benefit will be August 6th at the county fairgrounds beginning at 2 p.m.

"Maxwell has not been able to work for a few months, and who knows when he will be able to work again after this round of


treatment," said Helton. "We are just trying to help them out during the hardest time they have ever gone through."

She is preceded in death by three sisters and one brother. Lora Roberts, Evelyn Camper, Mary Gray and Dexter Ellis.





Spice up summer meals with some fresh pesto pasta

I've grown herbs at the farm for all our married life, and have always loved the days when we need to harvest basil, whether just a little for a recipe of pesto, or big bunches for homemade pasta sauce.

When you come in the house and smell that fresh basil, it just fills your senses and always makes me think, "summer!" I think it has magnetic properties, the way it pulls my husband and kids into the kitchen to follow that tantalizing smell!

Any other year, I'd say basil is one of the easiest things to grow, and most rewarding, but this year, I just planted it in the wrong place and it's looked pathetic all season. It wasn't helped by the heat waves, either. I usually have several plants, more than enough to make a batch of homemade pasta sauce, several batches of pesto to freeze, or even to just use some in canned tomatoes.

But this year... there's not even enough leaves to pick and they are all shriveled. I put out a call on Facebook, and good friends and supportive readers Benny and Diane McClung clipped me some and delivered it to me within hours! Dianne has a beautiful planter with several herbs, and clearly it's been enough to share basil with me and others, she says. Basil loves to be trimmed back, and it will continue putting out until frost, when it becomes a slimy mess, so pick it all before then. And pick off every bloom. Once it goes to flowering, the taste changes.

Share the pesto recipe

What happened was, I cleaned out my freezer, and found some of last season's frozen pesto and made one of our favorite family summer side dishes, pesto pasta. My buddies at work smelled my leftovers I brought for lunch (again, that basil smell is irresistible!), and I thought I should share the recipe that is a standby for us every summer.

Having grown up in a pesto-free home, completely ignorant of the green oily stuff I'd seen in cookbooks, I harbored doubts about pesto (basil plus nuts?? ick!) until I attended a Homemaker event years ago with local extension service homemaker Betty

Fulton. She brought her food processor and all the ingredients and made up a batch for the crowd, and I was sold. It was so much easier than I anticipated, and I've been making it ever since, just like she showed that day, with walnuts and bow-tie pasta!

Ingredients for basil pesto

- You need fresh basil leaves at least a cup or so, and you don't have to do anything but make sure they are clean and dry, and pulled off the stem.
- Clove garlic, or you can use the kind that comes minced in jars; but not garlic powder.
- Olive oil the more you pay, the better it tastes is the rule here. At the very least, get extra virgin olive oil (EVOO).
- Parmesan cheese -not ever the powdery stuff. Ever. The bagged kind is perfectly acceptable and we use insane amounts of it. A good chunk you grate yourself will elevate any meal or recipe.
- Walnuts or pine nuts. Pine nuts are what you always see in pesto recipes, but years ago, when Mrs. Betty demonstrated, they were hard to come by around here, so I have always used walnuts like she did. We love them in pesto; even my kid that eschews nuts. Use halves or pieces.

- Salt and pepper.
- You need a food processor, but it need not be fancy - I made this batch with a \$10 one from Walmart!

How to make it

Load up a food processor bowl with at least a cup of loose basil leaves. Add in about 1/4 cup of walnut halves/pieces, and a couple cloves of garlic, peeled. On top of that put about 1/4 cup or so of Parmesan cheese, and some salt and pepper. You'll learn what you like and be able to add by taste.

Put the lid on and pulse a few times. You want the processor to chop everything finely, but not make a mushy mess. Use a spatula to scrape the sides so everything is combined evenly.

Replace the lid and, while pulsing, drizzle in about 1-3 tablespoons of EVOO, just enough to help it all join together; you don't want it too oily. Taste and add salt and pepper as you like.

That's it!


Boil up some pasta. We always use bowties, but the spirals work well, too. Cook according to directions; drain and return to the pot. Put a few spoonfuls of pesto and stir it around, letting it get all over your pasta. You can add more Parmesan at this time, too.

Serve this as a side dish to some grilled meat, or get adventurous by adding in cherry tomatoes, artichoke hearts, or some smoked chicken breast and it makes a one-dish meal. Add in a few red pepper flakes when making the pesto for an extra kick.

The leftovers keep well and make a good lunch the next day!

You can put the pesto in small containers and freeze. It keeps well, and just add it to hot pasta straight from the freezer.



Conservation Corner

HR 8167 is Wrong for Sportsmen, Conservation, and the Second **Amendment**

Bill in US House would cripple funding for program that helped save white-tailed deer, wood ducks, wild turkey and more

Wildlife Mississippi has expressed its staunch opposition to a bill, that if passed, would cripple wildlife conservation permanently not only in Mississippi, but throughout the United States. It would destroy the North American Model of Wildlife Conservation.

H.R. 8167, the so-called Return Our Constitutional Rights Act of 2022, will eliminate the 85-yearold Pittman-Robertson Act (coauthored by the late U.S. Senator Key Pittman, who was born in Vicksburg), a program that helped save white-tailed deer, wood ducks, wild turkey, and other wildlife from near extinction to huntable populations, and continues expanding their populations today. The bill disguises this senseless result by claiming to defend our Second Amendment rights.

Sportsmen-there are more than 780,000 sportsmen and

women in Mississippi and 8 in 10 of them state that a candidate's position on sporting issues is important in who they vote forare the best promoters of our Second Amendment rights. This is an unbelievably confused bill, yet many members of the U.S. House of Representatives are supporting it. If passed, this bill will destroy the nation's most powerful wildlife conservation funding program in the name of the Second Amendment, contrary to the wishes of the Second Amendment's strongest supporters. Our ethical exercise of these rights is inseparable from the wildlife conservation programs this bill will eliminate.

The Pittman-Robertson Act redirects a user-supported federal excise tax on firearms, pistols, ammunition, and archery equipment to state wildlife managers. This is the nation's most successful wildlife conservation funding program and it is the envy of the world. The bill would essentially "gut" funding for the Mississippi Department of Wildlife, Fisheries, and Parks. It would change the funding mechanism to an already unpopular tax on oil and gas leases from public lands and waters, even for non-coastal states. Furthermore, game conservation programs, such as those for deer

and turkey, would no longer be funded; funding would be shifted to non-game programs.

Pittman-Robertson has generated over \$15 billion-\$116 million to Mississippi aloneto conserve wildlife, enhance public recreational shooting opportunities, acquire state wildlife management areas for hunting, fund hunter education programs, provide technical assistance to private landowners, and recruit America's next generation of hunter-conservationists. In 2021 alone, over \$1.1 billion was raised and distributed for on-the-ground funding for state wildlife agencies.

Without the funding, advocacy, and input from sportsmen, wild places and wild things would not exist in the health and abundance they do today that all Mississippians, and all Americans, enjoy. This bill has recommitted hunter-conservationists to explaining and reminding elected officials of this fact and what makes wildlife and habitat conservation work not only in our state, but throughout our great Nation.

It is so sad today to go by the house that was once so full of life. The beauty of Lila's paintings decorated the walls and her sister Paula's piano playing filled the house with beautiful music.

The Rileys knew sadness. Their oldest son, Pete, was killed in World War II in the South Pacific and his body was never returned to his homeland for burial. He left a small daughter, Paula, who the Rileys adopted and she lived a wonderful life beside the train tracks, thanks to caring grandparents.

After Mrs. Riley's death, the house went back to the railroad. Her granddaughter Sheryl remembers as the hearse took her body from the house,

the train stopped when the men heard of Mrs. Riley's death and the men lined up on the rails with their caps off, heads bowed, paying tribute to a lady they had watched in her beautiful garden over the years.

Lila is much like her mother as she loves beautiful flowers and cooking

on Main Street and assisted buyers with decorating ideas. She moonlighted at Country Squire Restaurant, and her artwork could be seen displayed on all the walls

She later got a full-time job with the Corps of Engineers during the construction of the Tenn-Tom Waterway. Paintings of the Waterway will be featured at the Burnsville Waterway Festival on September 24th. You can also go to the Tishomingo County Art Council site and see an interview with Lila about her work on the waterway.

Do your kids have all the right shots for school?

The Tishomingo County Health Department, located at1508 Bettydale Drive, in Iuka, Mississippi, will hold a special walk-in immunization clinic for school registration on July 15, and July 29, 2022, from 8 a.m. until 4 p.m.

During this clinic, the health department staff will have additional nursing staff available to provide adolescent immunizations so that parents can complete the process quickly and efficiently. Parents should bring a copy of their child's immunization record.

There are required vaccinations for first-time school entry in Mississippi as well as a requirement for 7th grade entry. Parents must provide the school with a Certificate of Immunization Compliance (Form 121) prior to school entry.

Form 121 can be obtained from your child's immunization provider, but MSDH now offers a convenient way for parents to check their child's immunizations record online and print out the required Form 121 or download the

document to send to the school.

MvIR Mobile is an online portal that gives users access to their official state immunization records. MyIR Mobile allows users to not only see their own immunization records, but to also add family members to their profiles to see if their child is up-to-date or needs their next vaccination. If none are needed, a certified Form 121 can be downloaded or printed.

MyIR Mobile requires identity verification through a phone number or email address to keep records safe and secure. Only immunization records of Mississippi residents are accessible through this program. MyIR Mobile is available at www.MyIRMobile.com.

You may check with your physician or county health department if you have questions about which immunizations your child will need. Childhood vaccinations are available at county health departments by appointment.

- Hand sanitizer will be provided for use for students throughout the day.
- Proper hand washing and hygiene will be taught to students and encouraged throughout the day.

Visitors:

Visitors are welcome on campus. However, if a visitor has any symptoms of illness, he/she should not enter the

Student positive case in a classroom:

- When a student tests positive in a classroom, the school will notify students/staff in the class(classes) that a positive test has occurred.
- Staff will not conduct contact tracing at this time, nor will staff require quarantine for exposed individuals.

Employee positive case in a classroom:

- When an employee tests positive, the school will notify members of his/her class and staff that a positive test has occurred.
- Staff will not conduct contact tracing at this time, nor will staff require quarantine for exposed individuals.

Students/employees that arrive at school with symptoms/fever:

When a student or employee arrives on campus with a fever of 100.4 or higher or has symptoms consistent with COVID-19, he/she will be immediately taken to the nurse's office. The student/employee will be isolated from the general population,

- and additional medical analysis will occur.
- The student or employee will be required to leave school and seek medical attention.

Covid-positive cases:

- Students/Employees with a positive test will follow the CDC/MSDH protocol and be able to return to school when the following criteria are met:
 - Isolate 5 days from a positive test (documented) or onset of symptoms (documented by a medical professional), and
 - Fever-free for 24 hours without fever-reducing medication
- Students/Employees with a positive HOME test will be required to present proof of the positive test.
- Symptoms of COVID-19 are as follows:
 - Fever of 100.4 or over
 - A cough not attributed to another health condition
 - · A sore throat that cannot be attributed to another health condition
 - Nasal congestion/runny nose that cannot be attributed to another health condition
 - Body aches
 - Loss of taste/smell
 - Diarrhea
 - Nausea/Vomiting
 - Sweats/Chills

Students/staff in quarantine

Per the TCSD policy passed on January 10, 2022, only COVID-positive individuals are required to isolate.

Vaccines/quarantine exemptions

• COVID-19 vaccinations are voluntary

- and not required of staff or students. Per TCSD policy, only COVID-positive
- individuals must isolate. Students/Staff are not required to quarantine, regardless of vaccination status per TCSD policy, unless showing symptoms.

Covid-19-related absences:

- Students who miss school due to a positive COVID-19 diagnosis will be counted absent. As with all other sicknesses, a doctor's excuse or a parent note (allowed 3 per semester for 3 days) will make the absence EXCUSED. However, the absence will count against the student and against a student's test exemption status at the end of the semester/year.
- Staff that miss school due to a positive COVID-19 diagnosis will use sick days allotted by board policy. There are no longer any special provisions for staff for COVID-19-related absences.

Distance/virtual learning/ weather days

- Due to Mississippi State Board policy requiring synchronous (real-time) virtual instruction for 330 minutes daily, the TCSD will not offer a distance/virtual learning program at this time.
- If a student is absent, the parent may ask for work as in times past for students to continue learning. Online instruction that is not in real-time is an option as well as paper packets if needed. The parent should contact the school and/or teacher to ask for






Local conservation district hosts regional meeting
