An election will be held Saturday, August 13, to elect four (4) members for positions on the Board of Directors of Tishomingo County Electric Power Association. One director is to be elected for a three (3) year term for each of the following supervisor's districts: 3rd District, 4th District, 5th District and an Area at-large position. Members of the Association may vote for one person for each position on the ballot.

Extra Mile Recovery opens in Midway

Residential inpatient substance use disorder facility for women opens in historic Morris home

An historic home in the Midway community will have new life helping women overcome substance abuse problems, thanks to new owners with a heart for healing.

Helping clients get sober and making sure they're equipped with the tools they need to live a life of recovery is the goal of owners Scott and Carrie Smith, Scott explained during grand opening festivities last Friday.

The facility can house 15 women struggling with addiction in a beautiful atmosphere - an antebellum home place in the woods of central Tishomingo County.

This residential inpatient facility joins a successful one the company has had for six years for men in Mantachie.

Extra Mile Recovery has 30, 60 and 90 day programs, and can meet the needs of court-ordered drug rehabilitation.

The therapy, supervised by on-site counselors, combines a variety of evidence-based therapies, personalized planning, and comprehensive

support that enables clients to build a foundation for recovery that lasts the rest of their lives

After successfully completing the program here, women can move on to places like the Bridge House in Burnsville, which helps them further integrate back into society by helping them get work and continue their therapy and lifestyle coaching they learn at Extra Mile.

"This is the only rehab facility in the county and will be a fantastic resource that meets a huge need in our county," said Ryan Glover, board president of Tishomingo County Community Coalition, a local organization that helps fund Bridge House, and also Safe Haven, a shelter for homeless people here in the county.

Historic home has new life

The Smiths purchased the former Morris house from Pam Morris back in December and have worked to bring it up to code for the group living home. They have had residents on-site since June, and many were there to testify to the changed lives they have achieved through the therapy at the home.

"I'm so happy that this home that we have loved so long can be put to such a good use," said Pam Morris, who was at the opening. Pam lost husband Paul Morris more than a year ago to sickness after a valiant fight against cancer during the pandemic. "I know he would be proud."

Successful completion of the programs offered can help residents have their charges set aside, as long as they continue to live clean.

Qualifying Underway for Local November Races

Incumbent 1st District Supervisor Eric Booker has been the first qualifier for the special election to fill the unexpired term of Brandon Grissom.

Local races on the November 8th General Election ballot include 2nd District school board member and 1st District Supervisor, which is a Special Election by order of the Board of Supervisors to fill the unexpired term of the late Brandon Grissom.

Candidates may start qualifying for 2nd District School Board & 1st District Supervisor on August 10th and qualifying will end on September 9th at 5 p.m.

Registered Voters who are interested in seeking either of these offices may pick up the proper paperwork at the circuit clerk's office. If necessary, a run-off election will be held on November 29, 2022 to determine the winners.

Non-partisan elections

The office of school board member is a non-partisan race, and because the 1st district Supervisor position is a special election it's non-partisan also. At the time of qualifying candidates must complete a petition containing signatures of qualified electors of the district in which they seek election. School Board candidates must collect 50 signatures and Supervisor candidates must collect 15 signatures.

Supervisor candidates must pay a \$100 qualifying fee to the county via the Circuit Clerk. No qualifying fee is required for school board candidates. All prospective candidates shall be a qualified elector and a resident of the county or district for two years preceding the day of election.

School board candidates must have obtained a high school diploma or its equivalent. Other qualifications; never have been convicted of bribery, perjury or other infamous crime, being a crime punishable by a minimum of one (1) year confinement in the state penitentiary, i.e., all felonies, unless pardoned for the offense (Miss. Const. of 1890, Article IV, § 44).

Tax Collector opening a new branch office in Belmont

Tuesdays and Thursdays, tax collector office services will be available at new Main Street office

Folks in the south end of Tishomingo County will have a new, convenient way to do some county business when Tax Collector Jena McNatt opens a new part-time office on Belmont's Main Street in the coming weeks.

According to McNatt, the office will provide all the services provided in the Tishomingo County Courthouse Tax Collector's office: vehicle tags, paying taxes, registering mobile homes, and more.

"Everyone doesn't realize it, but getting to the courthouse can be a 30-mile one-way trip for Belmont, Dennis and Golden residents," said McNatt. "That could be 60 miles round trip, and for working folks, getting up there during business hours can be a real inconvenience, if not just impossible."

"This will be a huge convenience for

our folks and we are so pleased to have her in town," said Belmont Mayor Buddy Wiltshire.

Tax Assessor Wayne Crum will also be at the office during "homestead season" - January through March, providing his office's services.

She's still getting network and computers set up for the move, McNatt explained, but plans to be able to hold 8 a.m. to 4:30 p.m. office hours as soon as next week. The office is at 110 Main Street, next to Wildflowers Florist.

Linda can remember working in the back of the store when she was young and my husband, Jimmy, worked at Burrows carrying groceries for people before he could even drive.

Ms. Willard was born and raised in Iuka on Snowdown Road, the daughter of John and Leona Helton Thorne. She was the youngest of eight children: Kerry Thorne; Ed Thorne; Gene Thorne; Corrie Thorne Ramsey; Ora Thorne Lofton; John Albert Thorne; Roscoe Thorne; and Willard Thorne Burrow.

In 1943 Tom Burrow, of Fayette County, Alabama came to Iuka working with Mitchell Construction Co., in the asphalt mines in Margerum, AL. While in Iuka he met and married Willard Thorne on July 1, 1944. The couple moved to Tuscaloosa and later, at the insistence of her father, returned to Iuka to make their home. In 1947, the Burrows bought Mr. Clingan's Grocery on Front Street and served customers until their retirement in 1968, at which time they sold the business to Austin and Gladys Curtis.

The Burrows were much loved by the people of Iuka, always willing to lend a helping hand to those who needed assistance. Mr. Tom spent his retirement years raising cows on his farm at Snowdown.



J. T. Burrow Grocery and Market - Located on Front Street in Iuka from 1947 till 1968, three stores down from the Iuka Guaranty Bank. Today it is being renovated by Terrie and Sidney Whitehurst for Iuka's first art gallery. The architecture is much like the buildings located on Front Street, but the front of this building was changed to all glass sometime in the past. Notice the screen doors on the front. A recent photo I published showed Iuka during a Labor Day Parade in 1964. It appears the front of the building had not been changed from the original design.

Menthol Cigarettes: More Addicting than Regular Cigarettes

Rankin County resident, 50-year-old Cissy Jones smoked menthol cigarettes for over 20 years. "I started when I was 16. I was young, dumb, and those menthol cigarettes just tasted better."

Tobacco companies add menthol to cigarettes so that they feel less harsh, which makes them more appealing to young people. The attractiveness of menthol is compounded by the fact it is more addictive. Currently, menthol is the only allowable cigarette flavoring under federal law.

Tobacco companies continue to market menthol cigarettes in poor and under-served communities.

Mississippi has the fifth highest rate of smoking in the nation, and the majority of menthol smokers in the state are Black.

The chemicals found in menthol interacts in the brain to enhance nicotine's addictive effects, making it harder to quit. Black Mississippians who smoke menthol cigarettes are more likely to experience health consequences, such as heart attack, stroke and lung cancer due to preexisting health disparities as shown in the data collected by the Centers for Disease

Control and Prevention (CDC).

While tobacco use has dropped off over the last 20 years, use of menthol cigarettes within groups of smokers has continued to increase, according to the CDC.

"I only quit seven or eight years ago," said Cissy. "Had they taken menthol off the market, I would have quit a lot sooner. I just couldn't smoke those regular ones. And it's too easy, my drug was on every corner."

The Mississippi State Department of Health (MSDH) offers free options for those who are ready to quit.

Our "Ready. Set. Quit" program has a hotline you can call. 1-800-QUIT-NOW. "We are real people who are ready to help!" said Sonya Sanderson, Director of the Mississippi Tobacco-Free Coalition of Prentiss and Tishomingo Counties.

Cissy is glad she quit. "I can breathe now, and I don't stink. I've got freedom from the addiction," she said.
