## Fulton St. to Front St. - Downtown **luka's latest renovations**

Two historic downtown Iuka buildings that have been under construction for the past year are ready for business!

Over the past summer, citizens and visitors have marveled at the many construction projects going on downtown, and we anticipate more announcements as projects progress, making our downtown a true destination and treasure.

#### 127 Fulton Street

A contract has been signed for a new restaurant at 127 Fulton Street, according to owner Chris Cornelison. Having completed partial renovation of nearby 123 Fulton for his Solutions Rx business, he said he just couldn't bear to see the

former Cafe Memories location remain empty.

"I've loved investing in my hometown, and seeing how everyone seems to have the same enthusiasm - all the downtown renovation - I'm glad to be a part of something bigger," said Cornelsion. "Everyone has been so supportive and excited about the restaurant."

Over the past year, he and his team, including Adam White and Liz Cummings have opened up not only the bottom floor, but also the second floor of the builsing that dates from the late 1800s. They added restrooms upstairs, and created a topquality professional kitchen.

As for the striking black and white paint on the front of the building, Chris said he wanted something upscale and

white, with black trim, like a tuxedo. Liz Cummings determined what details would be accented in black, and with the gas flame lamps out front, the place is just amazing; fitting in with the traditional downtown, but standing out with class.

A group with local connections has signed a contract and Cornelison says they plan to be operational before the

## **NMHS Covid treatment** team delivered hope

Patrick tells of one instance when they gave 48 infusions of monoclonal antibodies at NMMCluka in one day.

TUPELO -Throughout the COVID-19 pandemic, the Outpatient Infusion team worked behind the scenes but was key to keeping people out of the hospital and setting them on the road to recovery.

The Outpatient Infusion team was responsible for organizing and administering monoclonal antibody infusions throughout North Mississippi Health Services. The infusion reduces the illness in individuals at high risk for progressing to severe COVID-19 and hospitalization.

"As soon as we learned the monoclonal antibodies would be available for outpatient use. a multidisciplinary group from across the health system began

work to provide the drugs to **COVID-positive** patients who met the criteria," says Patti Hawkins, system director of Ambulatory Pharmacy Services



and 340B, which includes Outpatient Infusion. "Coordination and communication were critical. With support from the team, a dedicated infusion center in Tupelo was established within two weeks and ready for operation when the drug

### Covid treatment team, continued from front

NMHS gave its first dose of monoclonal antibodies to treat COVID-19 on Dec. 3, 2020. Since then, almost 10,500 doses have been given at NMHS hospitals in Tupelo, Amory, Eupora, Iuka, Pontotoc and West Point, Mississippi, and Hamilton, Alabama, as well as at the mobile testing site that was established near the Mall at Barnes Crossing in Tupelo.

This team worked long hours, including making and taking phone calls after hours from home. Through it all, they were focused on serving people and minimizing the effects of this deadly virus.

"Our local doctors felt

strongly that we should provide this service locally to keep them from having to travel to Tupelo for the infusion," says Kathy Patrick, chief nursing officer at NMMC-Iuka. "Being able to offer monoclonal antibodies at our local hospital was a big win for our community."

The sites took a team approach—if one facility couldn't accommodate a patient, they would ask other facilities if they could. "We were being bombarded with referrals, not just locally, but from everywhere," Patrick says. "Every time we got a phone call or fax, I'd say 'yes, go ahead and schedule them here.' I could not stand to turn anyone away knowing we could give them

something that could possibly save their life."

Patrick tells about one instance when they gave 48 infusions of monoclonal antibodies at NMMC-Iuka in one day. "Every person in the hospital was involved to keep it moving," she says. "Every treatment room was full, and while we would take a patient back to their car, Housekeeping was preparing the room for the next patient. Pharmacy and Admissions staff were amazingthe ER doctor even came around and helped us wheel patients back to their cars. I still get teary-eyed even thinking about it. This was the most incredible thing I have seen, and we did not turn away anyone that day!'

## Farming in later years one of the sweetest memories

from more than 40 years in the

classroom, there seemed to be a few things that kindled some nostalgia for my early years as a farmer's daughter. After a few retirement years, Chester's health improved and we, just the two of us, got farming in our blood and we decided to make a go of it, much to the dismay of our family.



"You don't need to do that!" "You aren't able!" or "You're too old!" We listened to no advice, and did as

we had planned. I'd help Chester get up on the tractor, and we'd head for the Cypress Pond.

We owned a planter and corn picking machine, a wagon, and had a couple tractors lying around idle. We had anything we needed and we decided to put them to work. It was really fun!

We'd get up and head to the Cypress Pond, about 5 or 6 miles from our house. It was a large pond, with about 300 acres of farm land running parallel with the Alabama line with Bear Creek between

We'd stop at the Country Store and plan our snacks and dinner and head east. We were confident that we could still work part of the farm and the rest lay fallow. We two were the only ones for really miles around. And there were many obstacles that we didn't anticipate.

Beavers were doing a lot of damage to the bottom fields. They were building dams up and down the feeder ditches. A big dam was built just a few feet from where it emptied into the canal. We had

to cross the ditch and the water was backed up. We were in the 1986 Chevy pickup truck, but every morning, the dam had to be torn out and we would wait for the water to go down so we could cross. Chester would drive up to the ditch, and I would get out with boots on and tear away the new dam. When the water was low enough, we drove across for a full day of farming. The clever beavers would build it back every night. They probably took a nap while we were working!

By then, Chester was already disabled; he had diabetes and other problems and used a walking stick.

Did you know beavers build their homes with upstairs rooms, so they can retreat to the upper levels when the water rises? I didn't learn that at Cypress Pond, but teaching 7th and 8th grade science.

We'd park under the big trees in the

center of the farm. Oil had to be checked and the plows greased. Chester would direct me and I'd do the getting-ready. Then I'd give him a big push to get into the seat, and here we'd go. He broke up the land with a gang plow, and I'd level it out and get it ready for planting with a disc. I filled the hoppers and off he would go with the planter.

I would sit on the tailgate of the pickup and crochet. If the tractor stopped, I'd get into the pickup and find out what the problem was. After addressing the problem, I'd head back to the shade and my crocheting.

I crocheted a full tablecloth that spring!

What a beautiful life we were having. Seeing progress made and just being together after all the past working years and raising a family. God had so blessed us and we were thankful.

## Film explains well possible ends of early American explorer

I've always been interested in the ultimate frontier story of Lewis and Clark, the leaders of the expedition U.S. President Thomas Jefferson sent to explore the new country of America. One of my favorite reads is their story, "Undaunted Courage, The Pioneering First Mission to Explore America's Wild Frontier," by Stephen E. Ambrose. I would rate it as one of the best historical novels I have read, enjoyed so much so that I read it twice!

Since reading the novel my lovely bride and I have often stopped by Grinder's Stand on the Natchez Trace to visit Meriwether Lewis' grave. We don't think about it here in 2022, but the Lewis and Clark expedition to the Pacific in 1804-06 was just as dangerous and unknown as the first manned mission to the Moon, maybe even more so. Meriwether Lewis returned to a grateful

nation as a hero, much like Neil Armstrong did as he returned from the moon 163 years later. but he soon was reportedly suffering from depression, anxiety, and alcoholism. Some scholars have noted that he returned from the monumental trip unable to adjust to sedentary life.

In 1809 Lewis' reportedly committed suicide at Grinders Stand while returning to Washington to attempt to resolve unpaid drafts, which if left unpaid would potentially result in ruinous debt. Time has revealed his death may not have been by suicide, but could have been other more sinister

Enter Clark Richey, the

writer and director of the just released film "Mysterious Circumstance - the Death of Meriwether Lewis." I had the pleasure of seeing the film at the Corinth Coliseum last Saturday night and enjoyed it immensely. Filmed on location at the Butler Cabin near Bay Springs Dam and at Tishomingo State Park, the movie presents four different endings to the life of Meriwether Lewis, each of which is a believable representation of what may have actually happened. Richey's film is excellently presented, easily moving from one potential cause of death to another until at the end vou realize it is really a mysterious circumstance. All of the actors were excellent, especially Tishomingo County's own Rider Mayo and Keandre Wicks. The pace of the movie is certainly a bit slow in today's world, but at the same time, does in a way move you back to



a slower place in time.

On a side note, watching a movie about the death of Meriwether Lewis in a coliseum constructed in 1924 and surrounded by the history of Corinth really sort of moves you back in time.

The film has won awards at the Gasparilla International Film Festival, Los Angeles Film Awards, Montreal Independent Film Festival,

Oniros Film Awards, and other organizations. The film has been extended

to one more showing at the Corinth Coliseum on Thursday. September 15 at 7 p.m.. I highly recommend you go see this movie!

Online reports indicate the movie will be coming to video on demand and digital platforms on October 28th.

WHEREAS, the Board of Aldermen met on the aforesaid date, and considered all of the above items and determined that the Mayor's recommendation as to the ad valorem tax levy for the next fiscal year should be approved.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Aldermen of the City of luka, Mississippi as follows:

1. The Board of Aldermen of the City of luka hereby resolves that the ad valorem tax levy for the next fiscal year shall not be increased; and hereby establishes the millage rate for the City of luka at 17.23 mills shall be for the following purpose:

15.32 mills

B. Fire Fund 0.34 mills C. Library Fund 1.57 mills TOTAL MILLAGE 17.23 MILLS

2. The Clerk of the City of luka is hereby directed to certify a copy of this Resolution to any other taxing district of which the Municipality may be a part, to the State Auditor, to the State Tax Commission, and to publish this Resolution one (1) time in the Tishomingo County News.

3. The foregoing Resolution was proposed on Motion made by Alderman Robertson, seconded by Alderman Nancy Stripling and being put to a vote, received an affirmative vote of all members present as follows:

## Pleas heard in Tishomingo County Circuit Court

Last week in Tishomingo County Circuit Court, sentencing and pleas for felonies were heard by Circuit Court Judge Kelly Mims.

Nathaniel Lee Green, 36, of Golden, pled guilty to possession of methamphetamine (2g – 10g) and was sentenced to 8 years in custody of Mississippi Department of Corrections, all suspended, plus 5 years probation.

Adam Lando Creasy, 35, of Cherokee, pled guilty to receiving stolen property (\$1,000 - \$5,000) and was sentenced to 5 years in custody of MDOC, all suspended, plus 5 years probation.

James Legrant Skelton, III, 61, of Iuka, pled guilty to possession of a weapon by a convicted felon and was sentenced to 10 years in custody of MDOC, all suspended, plus 5 years probation.

Jonathan Derek Durham, 42, of Burnsville, pled guilty to possession of methamphetamine with intent to distribute (2g - 10g) and was sentenced to 20 years in custody of MDOC, 15 suspended, 5 years house arrest, and 5 years probation.

Justin Reese Ewing, 27, of Belmont, pled guilty to one count of fondling and was sentenced to 15 years in custody of MDOC, 11 suspended and 4 to serve, plus 5 years post-release supervision.

Kaylen Mae Blanchard, 27, of Iuka, pled guilty to possession of methamphetamine (.10 g - 2g),

and one count of credit card fraud, and was sentenced to 3 years in custody of MDOC, all suspended, plus 3 years probation.

Walter Joe Shelton, Jr., 49, of Burnsville plead guilty to driving under the influence of alcohol for the third time and was sentenced to 5 years in custody of MDOC, two years house arrest and 3 years post release supervision.

**Charles Curtis** Webb, 31, of Oxford pled guilty to possession of methamphetamine with intent to distribute (10g -30g) and was sentenced to 30 years in custody of MDOC, 3 years house arrest, balance suspended if successfully completed, and 5 years post release supervision.

Judith Benson, 41, of Tuscumbia pled guilty to possession of meth (2g - 10g)and was sentenced to 8 years in custody of MDOC, all suspended and 5 years post release supervision.

Fragel Wayne Smith, 38, of Iuka pled guilty to secretly filming/photographing for lewd purpose and was sentenced to 5 years in custody of MDOC, with credit for time served and the balance suspended and 3 years post release supervision.

Steven Nicholas Glidewell, 34, of Burnsville, pled guilty to receiving stolen property (\$5,000-\$25,000) and was sentenced to 10 years in custody of MDOC, all suspended, and 5 years post release supervision.

Sandra Dee Grubbs, 62, of Tishomingo, pled

guilty to possession of methamphetamine (.10 g -2g), and was sentenced to 3 years in custody of MDOC, all suspended, plus 3 years probation.

Patrick Martin "Marty" Wood, 47, of Fulton, pled guilty to burglary of a dwelling with intent to commit larceny, and embezzlement with a value of more than \$1,000 but less than \$5,000, and was sentenced to 25 years in custody of MDOC, all suspended, plus 5 years house arrest.

Pamela Ann Thornburg, 57, of Tishomingo pled guilty to possession of methamphetamine (.10 g - 2g), and possession of oxycodone, and was sentenced to 3 years in custody of MDOC, all suspended, plus 3 years probation.

Jessy Jason Green, 42, of Iuka pled guilty to taking a motor vehicle valued \$1,000-\$5,000 and was sentenced to 5 years in custody of MDOC, 3 suspended, 2 to serve and 5 vears probation.

Bently Lee Moss, 41 of Tishomingo pled guilty to burglary of a building and was sentenced to 7 years in custody of MDOC, with credit for time served already.

Jason Anton Ziarko, 44, of Dennis pled guilty to possession of methamphetamine with intent to distribute (2g – 10g) and was sentenced to 20 years in custody of MDOC, all suspended, and 5 years probation.

Anthony Vescio, 58, of Iuka, pled guilty to taking of a motor vehicle, greater than \$1,000,

less than \$5,000; possession of meth .10g-2g; and child endangerment (child testing positive for controlled substance; and was sentenced to 10 years in custody of MDOC, 3 years house arrest, and 5 years probation.
