## District gets post-pandemic A

**Tishomingo County School District to earn first new grade since the start of the pandemic**

The Tishomingo County School District will earn an "A" rating for its performance in the 2021-22 school year when the Mississippi State Board of Education approves official grades for Mississippi schools and districts on Thursday, Sept. 29.

Mississippi's schools and districts are graded on an A-F scale. The grades are part of the state's accountability system, which helps teachers, school leaders, parents and communities know how well local schools and districts are serving students.

The Tishomingo County School District's "A" grade is largely due to the progress students made during the 2021-22 school year rebounding after achievement declined in the first year of the pandemic.

"We are so excited to maintain our 'A' rating from 2018-2019. This success is due to the hard work of our students, teachers, staff, administration, school board, and parents through an unprecedented time in history. Our classrooms had to change dramatically due to COVID-19. Staff, students, and parents had to learn to use technology in ways we were not used to as well as deal with multiple absences caused by COVID or quarantine requirements. We truly have great teachers, administrators, and staff who had to totally shift daily operations to make

school safe to open while trying to ensure students could learn each and every day. So, to maintain an 'A' rating is phenomenal," explained Superintendent Christie Holly.

Statewide, Mississippi students made more progress than they typically do in one year as schools focused on accelerating learning after the first year of the pandemic. However, key factors including a student achievement decline in 2020-21, testing waivers, and one-year adjustments to the accountability system played a role in 2021-22 school and district grades. Therefore, the Mississippi Department of Education (MDE) advises caution when interpreting score changes between the 2018-19 and 2021-22 school years. In particular, substantial shifts in performance may

be temporarily influenced by factors associated with pandemic disruptions.

"As most people know, when the pandemic hit, the federal government issued waivers to states since schools were unable to test in 2019-2020, and the pandemic continued to impact students and staff in 2020-2021. While we tested in 2020-2021, those results were skewed due to the continuing effects of the pandemic on school attendance and required quarantines and isolations due to exposure and sickness. Those numbers were pretty low in comparison to where we were at the end of 2019. Our results from last year showed some incredible growth in certain areas that we know are not sustainable from year to year. That is why MDE is cautioning that school and district ratings may experience a pendulum 'correction' over

## Country Music marker placed in Burnsville amid successful Waterway Festival

The 2022 Burnsville Waterway Festival is in the books, and was biggest and best yet, according to organizers of the 30th annual event.

Two once-in-a-lifetime events marked the festival last Saturday: the placing of the Pete Pyle Country Music Trail marker, and the exhibit of all the Lila Ham Tenn-Tombigbee Waterway art, said organizer Kayleigh Bode. "That was really special, since it was the 30th annual event."

Visit Mississippi (the state tourism office) was represented by Maggie Lowrey, who was on hand to reveal the marker, along with many Pete Pyle descendants. The marker is one of many across the state marking important landmarks in country music history. This is the second in the county; Belmont has one for Mac McAnally.

The 5K race included 47 runners, and the car show looked like one of the biggest turnouts, as well, said Bode. The music was a highlight, including Ranger Doug Green, who performed some of Pete Pyle's songs in Burnsville, after performing at the Grand Ole Opry Friday night, and then heading back to perform there again Saturday night.

"We appreciate all the vendors and the great support we had from the community," said Ferrin Rainey, also on the festival committee. "We welcome everyone to get involved and help!" It was a great day for our little town," said Bode.

the next few years until we get back to data that is not impacted by missing test scores or severely impacted data from COVID years," said Holly. The MDE emphasizes the importance of looking at the individual components that contribute to school and district grades to get a more complete picture of student growth and achievement, particularly student proficiency levels. Mississippi's school grading system considers many indicators,

including how well students perform on Mississippi Academic Assessment Program (MAAP) tests for English Language Arts and Mathematics in grades 3-8 and high school, whether students are showing improvement on those tests from year to year, and whether students are graduating within four years. The system also factors in performance on the ACT and advanced high school courses and how well schools are helping English learners

and the lowest-achieving students make progress toward proficiency. "Our schools have worked very hard to increase graduation rates, offer accelerated coursework for our high school students, and increase growth rates for each child. If you look at our numbers, we have done an outstanding job in some of these areas," Holly explained. "The Tishomingo County School District has invested part of its COVID-relief funding into in-school tutors that work with students throughout the school year as well as after-school tutoring in the spring. Our goal was, and continues to be, to use these funds to put people in front of our children so we can close learning gaps caused by the pandemic."

"While we are very excited about our 'A' ranking, we know we have to continue to improve our student proficiency and growth numbers," said Holly. "We have seen English-language arts take more of a hit than mathematics. So, if possible, we need parents to help us with reading at home as much as possible, exposing children to grade-level vocabulary in the home, and using writing as appropriate with their child. Any time our parents can assist our students with ELA or math concepts in the home, it helps our teachers tremendously. Our kindergarten teachers are seeing a large learning gap in student learning as well.

We feel this is due to child care being limited during the pandemic and children not being exposed to critical information (colors, letters, and numbers) due to lack of child care. While we will definitely celebrate our success, we know we need to keep the momentum going to help our students' continuous learning," stated Holly.

clothing, and toward facilities like Safe Haven in Burnsville. Through Safe Haven, The Bridge House, and other resources, the Coalition helps a large number of people who are at risk, or have become homeless.

The proceeds from bingo will help them build or renovate a new transitional shelter, according to their social media. Since January 2020 they have provided more than 4,100 nights of shelter to residents from Tishomingo, Alcorn and Prentiss counties. They need more room, transportation and staff. If historical data means anything, the operation could be a

great help to those who help in the homeless, rehabilitation, and comfort industry that has long been a great need in the county. The long-established Tri-State Educational Foundation, funded by Riverhills Bingo gives millions in scholarships and education grants to hundreds of local residents every year. Anecdotally, the customers of local bingo places are from Alabama and Tennessee. "We know some people have a problem with bingo, and view it as gaming," said Glover. "Well, if it's the devil's money, its time we took some of it back to do good things with it."

# Shiloh National Military Park to Commemorate 160th Anniversary of the Battle of Corinth

CORINTH, Mississippi – On the weekend of October 1 & 2, activities commemorating the 160th anniversary of the Battle of Corinth will include cannon firing demonstrations, musket firing demonstrations, ranger-led programs, and a special visitor in the form of a camel representing Old Douglas, a pack animal used by the 43rd Mississippi Infantry.

Cannon firing demonstrations will take place at 11 am, 1 pm, and 2:30 pm on Saturday, October 1. Each demonstration will introduce visitors to the implements and ordnance used during the war and demonstrate the duties of wartime cannoneers. The 6-pounder field piece will be fired twice during each program.

Musket firing demonstrations will take place at 11 am and 2 pm on Sunday, October 2. Each demonstration will introduce visitors to the life of the average infantryman during the Civil War and the equipment he was issued.

Old Douglas the Confederate Camel will make three appearances on Saturday at 10 am, 1:30 pm, and 3 pm, and two appearances on Sunday at 1 pm and 2:30 pm. These half-hour long programs will discuss the use of camels in the U.S. military and the story of Old Douglas, the camel that carried the 43rd Mississippi's band instruments at Corinth.

**10:30 am – Daniel Murray of the 1st U.S. Infantry:** Join Daniel Murray, an Irish immigrant soldier, as he describes his life in the Regular Army during the war.

**11:30 am – Battery Robinette:** On October 4, 1862, the small earthen redoubt known as Battery Robinette was the focus of three attacks by Confederate infantry and dismounted cavalry.

**2 pm – Civil War Nurse: Nurse Kate Cumming** A young woman from Mobile, Alabama, travelled to Corinth and tended the wounded of both sides.

## Fall means all the apple recipes!

Fall means pumpkin spice to so many, it seems, but to me, fall means apples!

Lately I've been longing for apple crisp, apple dumplings, apple chunks in my oatmeal, apple pie or strudel... you get the picture.

Years ago I got a recipe for a fresh apple cake that we loved, so I was looking forward to making that. I found this recipe, and while it was a close second, I will nearly double up on the spices next time I make it. It was simple,

but a little bland. Perfect for breakfast, and my co-workers concurred, since I brought it to work Monday morning.

I did substitute coconut oil for the vegetable oil, as we were out, but it came out ok.

It's from one of my favorite online sources, Sally's Baking Addiction. If you want to get lost in some awesome recipes, check her out! She includes an option for a buttery brown sugar glaze, but I did not make it.

### Fresh Apple Cake

2 and 1/2 cups (313g) all-purpose flour (spoon & leveled)

2 teaspoons baking powder

3/4 teaspoon baking soda

1/2 teaspoon salt

2 teaspoons ground cinnamon

1/2 teaspoon ground nutmeg

1/4 teaspoon EACH ground ginger & allspice

1 cup (240ml) vegetable oil

1 cup (200g) granulated sugar

1/2 cup (100g) packed light or dark brown sugar

1 cup (180g) unsweetened applesauce

4 large eggs, at room temperature

1 teaspoon pure vanilla extract

2 Tablespoons (30ml) orange juice

3 cups (360g) peeled chopped apples (1/2-inch chunks, about 2-3 large apples)

OPTIONAL: BROWN SUGAR GLAZE

1/4 cup (1/2 stick or 57g) unsalted

butter

1 cup (200g) packed light or dark brown sugar

1/2 cup (120ml) heavy cream

small pinch of salt

1/2 cup (60g) confectioner's sugar, sifted

Preheat the oven to 350°F (177°C) and grease a 9×13-inch baking pan.

Make the cake: Whisk the flour, baking powder, baking soda, salt, cinnamon, nutmeg, ginger, and allspice together in a large bowl. Set aside.

Whisk the oil, granulated sugar, brown sugar, applesauce, eggs, vanilla extract, and orange juice together in a medium bowl. Pour the wet ingredients into the dry ingredients and whisk until combined. Fold in the chopped apples until combined. It will seem like a lot of apples and that's ok!

Pour and spread batter evenly into the prepared pan. Bake for 45-50 minutes. Baking times vary, so keep an eye on it. Around the 30-minute mark, loosely tent with aluminum foil to

prevent over-browning. The cake is done when a toothpick inserted in the center comes out clean.

Remove the cake from the oven and set the pan on a wire rack. Allow to cool for at least 30 minutes before topping or serving.

Right before serving, you can top the slightly warm cake with a dusting of confectioners' sugar or make the brown

sugar glaze in the next step.

The cake (glazed, dusted, or plain) can be served warm or at room temperature. Cover leftovers and store at room temperature for 2 days or in the refrigerator for up to 5 days. If you topped with a dusting of confectioners' sugar, note that the sugar will melt and disappear into the cake after a few hours.

The workshop represented a collaborative effort between the Tishomingo County Extension Service and the Tishomingo Arts Council, whose activities across the month of September have revolved around the culinary arts.

## Poet Matt Mason visiting, teaching locally

Accomplished poet Matt Mason visits our area for a series of poetry readings and workshops October 1st through October 3rd. No stranger to our area, Mason first visited North Mississippi while touring the Natchez Trace, a trip that itself inspired several pieces of poetry. He was appointed State Poet of Nebraska in 2019 and serves as Executive Director of Nebraska Writers Collective, festival coordinator for the Louder Than a Bomb: Great Plains Youth Poetry Festival, past board president for the Nebraska Center for the Book, and served as a consultant for the Nebraska Arts Council for Nebraska's Poetry Out Loud program (an NEA/Poetry Foundation program) until 2016. He has served on the board of directors for the Nebraska Literary Heritage Association, the Omaha Entertainment and Arts Awards, Friends of the Omaha Public Library, and the Medusa Project.

Mason has written about fatherhood and his father, relationships, religion and the Bible, and themes of Midwest and Great Plains life. His work is celebrated for its humor, allowing his deeper messages to be well received by wide audiences. He has over two hundred publications with numerous honors including a 2013 Pushcart Prize for his poem "Notes For My Daughter Against Chasing Storms."

Mason will appear at Pizza Grocery for a reading at 2 pm on Saturday,



October 1st in what represents the second in a long-planned series of visiting poets organized by the Tishomingo Arts Council and the Crossroads Poetry Project. Area residents are invited to come eat artisan pizza and listen to Matt as he reads from his newest book, 'At the Corner of Fantasy and Main: Disneyland, Midlife and Churros,' available now from The Old Mill Press. ## Local students do well in Kentucky chess tourney

PADUCAH, Ky. – Three students from Iuka Middle School took part in a scholastic chess tournament Saturday in Paducah, Kentucky, and fared well, with the school placing third in the tournament.

The tournament was the first one hosted by the Purchase Chess Federation – a western Kentucky nonprofit that raises funds for chess scholarships – since February 2020. Traditionally, the first tournament of the season is the USCF Membership Tournament which

provides K-12 students with memberships in the U.S. Chess Federation at a discounted rate. Students have to have USCF memberships to take part in the scholastic tournaments throughout the school year.

On Saturday, there were two players each in the K-3 (kindergarten through third grade) and K-5 (through fifth grade) divisions, so tournament officials combined all of the divisions into one big tournament.

Iuka Middle placed third in the team standings with nine points. McCracken County (Kentucky) was first with 12.5 points, while Paducah Tilghman was second with 10 points.

Seven schools qualified for the team standings with two or more players.

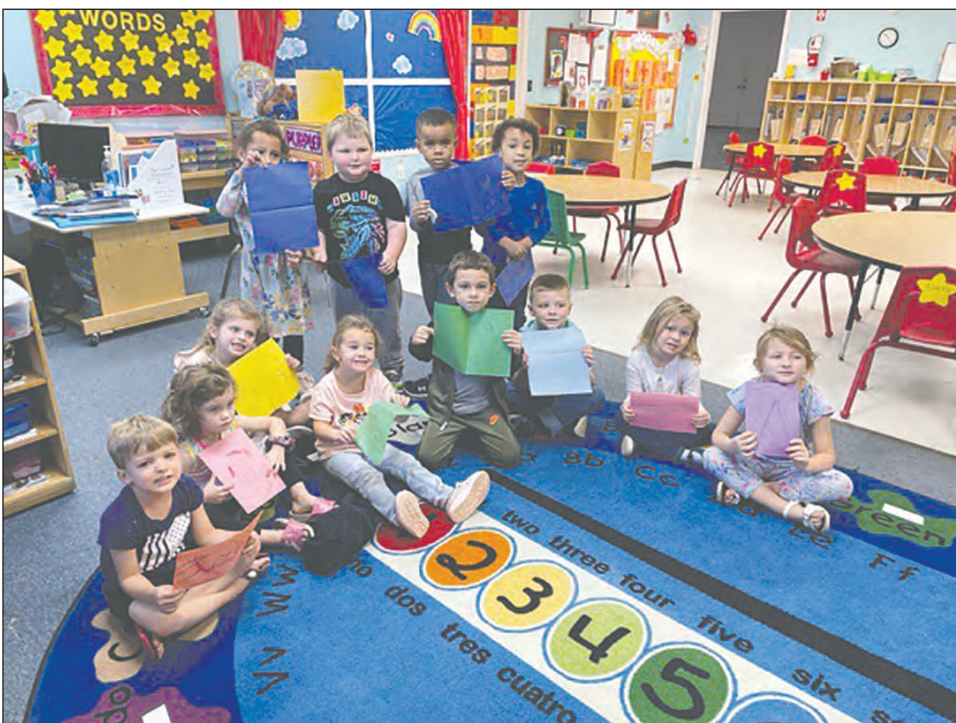
Eighth-grader Ella Grace

Kinney, of Iuka, placed third in the 30-player tournament with four points, beating four high school players but falling to fourth-grader Kyla Reeder – a homeschooler from Mayfield, Kentucky, who placed second overall – in the next-to-last round.

Iuka's Jackson Henson placed eighth with three points, while fellow Iukan Griffin Kinney placed 18th with two points.

Each win counts one point, while a draw counts as a half-point for each player.

(a) **Public service is a public trust** Each employee has a responsibility to the United States Government and its citizens **to place loyalty to the Constitution, laws and ethical principles above private gain**. To ensure that every citizen can have complete confidence in the integrity of the Federal Government, **each employee shall respect and adhere to the principles of ethical conduct set forth in this section**, as well as the implementing standards contained in this part and in supplemental agency regulations.

(b) **General principles.** The following general principles apply to every employee and may form the basis for the standards contained in this part. Where a situation is not covered by the standards set forth in this part, employees shall apply the principles set forth in this section in determining whether their conduct is proper.

(1) **Public service is a public trust**, requiring employees to place loyalty to the Constitution, the laws and ethical principles **above private gain**, **that employees shall not hold financial interests that conflict with the conscientious performance of duty**.

(3) Employees shall not engage in financial transactions **using nonpublic Government information or allow the improper use of such information to further any private interest**. [Insider Trading]

(4) An employee shall not, except as permitted by subpart B of this part, **solicit or accept any gift or other item of monetary value from any person or entity seeking official action from, doing business with, or conducting activities regulated by the employee's agency**, or whose interests may be substantially affected by the performance or nonperformance of the employee's duties.

(5) Employees **shall put forth honest effort** in the performance of their duties.

(6) Employees **shall not knowingly make unauthorized commitments or promises of any kind purporting to bind the Government**.

(7) **Employees shall not use public office for private gain**

(8) **Employees shall act impartially and not give preferential treatment to any private organization or individual.**

(9) Employees shall protect and conserve Federal property and **shall not use it for other than authorized activities**

(10) Employees shall not engage in outside employment or activities, including seeking or negotiating for employment, that conflict with official Government duties and responsibilities.

(11) Employees **shall disclose waste, fraud, abuse, and corruption** to appropriate authorities.

(12) **Employees shall satisfy in good faith their obligations as citizens**, including all just financial obligations, especially those - such as Federal, State, or local taxes - that are imposed by law.

(13) Employees shall adhere to all laws and regulations that provide **equal opportunity for all Americans** regardless of race, color, religion, sex, national origin, age, or handicap

(14) Employees **shall endeavor to avoid any actions creating the appearance that they are violating the law or the ethical standards set forth in this part**. Whether particular circumstances create an appearance that the law or these standards have been violated **shall be determined from the perspective of a reasonable person with knowledge of the relevant facts**.

(c) **Related statutes.** In addition to the standards of ethical conduct set forth in this part, **there are conflict of interest statutes that prohibit certain conduct**. **Criminal conflict of interest statutes of general applicability to all employees, 18 U.S.C. 201, 203, 205, 208, and 209**, are summarized in the appropriate subparts of this part and must be taken into consideration in determining whether conduct is proper. Citations to other generally applicable statutes relating to employee conduct are set forth in subpart I and employees are further cautioned that **there may be additional statutory and regulatory restrictions applicable to them generally or as employee of their specific agencies**. Because an employee is considered to be **on notice of the requirements of any statute**, an employee should not rely upon any description or synopsis of a statutory restriction, but should refer to the statute itself and obtain the **advice of an agency ethics official as needed**.

## Walking through the halls at TCLC brought back many memories

Two weeks ago my husband, Jimmy, was transferred from the Iuka Hospital Swing Bed to the Tishomingo Community Living Center for therapy and nursing care after suffering a sepsis knee.

TCLC, which was originally the Tishomingo County Hospital, is now a nursing home and assisted living facility. Visitors have to enter through the front door of the original hospital on the west side, have your temperature checked, sign in and get a mask.

This meant I had to walk all the way through the old hospital to get to his room. Each walk brought back memories of the old Tishomingo County Hospital. Until it was built back in the 1950's (a small facility) the only hospital Iuka had was Cosby Clinic or you went to Corinth or an Alabama hospital for emergency care.

Over the years many additions were made to the original facility, which was owned by the county. It was Iuka's only hospital and nursing home facility for many years, before it was sold to TCLC and became a private owned nursing home facility. At that time, North Mississippi Medical Center built a new hospital in Iuka on Hwy. 25 South. It now serves the people of Tishomingo County.

The halls in the old hospital are the same green tiles; the window is still there where we looked at the babies born daily.

I walked by the rooms where my grandparents and other relatives had died so long ago. Two waiting rooms were separated by the office area. One waiting room was turned into a patient room and that is where I remember my uncle Alton Biggs died. He had gotten terminally sick in Detroit and his only wish was to come home to Iuka for his last days. I was young, but you don't forget losing people you love. The walk through the old hospital brought back many sad memories!

The hospital was always full. I even remember beds being placed in the halls, near the operating room when the facility was full.

Even as late as 1996, the hospital provided *The Vidette* with a report of who was in the

The halls were always filled with the devoted nurses and orderlies that worked there. Jimmy had even worked in x-ray and later the ambulance service out of high school; and he has many memories of the old hospital and the employees. It is such fun to hear him and Ann Nunley talk about old times on the ambulance service.

The Tishomingo County Hospital was an important part of our community. Like the local Tishomingo Shoe Company located near it, the hospital employed many people. Young girls served as candy strippers and later went on to get their nursing degrees. Many of those original employees are

gone now but their memories still remain in the minds of those who visited or were patients at the old hospital.

I found these photos recently of some of the employees that were honored at the old hospital during National Nurses' Day, May 6. The year was not given, but the photos had appeared in an old issue of *The Vidette*.

I'm so proud we have good hospital and swing bed care here in our county; many rural areas are losing their hospitals, but ours remains a vital part of the community.

I would like to thank the staffs of the Tishomingo Community Living Center, Iuka Hospital, and North Alabama Medical Center for the care and kindness shown to Jimmy during his recovery.
